
How the FBI Protects the Swamp


I have no more information to offer the Committee and I do not wish to speak publicly regarding the incidents described in Dr. Ford's letter."

That's a strange use of the word "supposedly," and the phrase "up the ladder" is how former prosecutor Miguel Rodriquez had characterized Kavanaugh and other young lawyers in the office of Independent Counsel (OIC) Ken Starr when they were engineering the cover-up of the murder of Clinton White House lawyer Vincent Foster. The OIC had used the FBI to help cover-up the evidence that somebody drove Foster to Ft. Marcy Park, just minutes from CIA headquarters, where his body was found and a gun planted in his hand. Rodriguez quit under pressure for resisting the cover-up. He said those who were part of the cover-up would move up the ladder.

A major section of the authoritative website www.FBlcover-up.com is devoted to Kavanaugh's role in the cover-up of the murder of Foster.

As far as the "six background checks" on Kavanaugh are concerned, let's see them. Did FBI agents go back in time to investigate the party atmosphere at Kavanagh's Catholic high school Georgetown Prep? Did they examine allegations of sexual assault? Were the results of the investigations provided to the White House? Did they ever interview Kavanaugh friend Mark Judge, a former alcoholic who claims not to remember any sexual assault?

This is the same FBI which tolerated agents Peter Strzok and Lisa Page conducting an affair and plotting against Trump. Clearly, the FBI doesn't conduct adequate background investigations of its own employees.

Back in 2004, when the FBI was investigating the post 9/11 anthrax attacks, then-director Robert Mueller, who is now the Russia-gate prosecutor, ordered the draining of a Maryland pond, at a cost of \$250,000, in order to find "evidence" of the crime. Investigators found an old bicycle, a gun and a minnow trap that some anonymous government sources tried to portray as a biological warfare device. This effort was part of an effort to frame Dr. Steven Hatfill for the anthrax attacks. He sued the FBI and the Justice Department and won millions of dollars in damages. The FBI then blamed another scientist for the anthrax attacks, and he killed himself when the persecution became too much to bear. The evidence suggests Islamists from al Qaeda carried out the attacks with anthrax stolen from a U.S. lab.

In the Foster case, the FBI was part of a Deep State effort to get a grand jury witness, Patrick Knowlton, to change his story about what he saw at Ft. Marcy Park outside of Washington D.C. Knowlton said he never saw Foster's car, a silver Honda, at the time we know Foster's body was dead in the park. Instead, he saw a brown car and a suspicious individual. He testified as to what he saw and a young prosecutor named

Brett Kavanaugh put his name on a subpoena that resulted in Knowlton being harassed by government agents on the streets of Washington, D.C. to change his story. Knowlton never buckled to the pressure, a reason why his story is still to this day told in detail on the website www.FBlcover-up.com Nobody knows exactly why Foster was killed, but he had NSA binders in his possession and an FBI expert on sex crimes was assigned to the case.

FBI background investigations provide lots of raw information that lead people to different conclusions about the person in question. Their investigations are superficial and politically-motivated. Haven't we seen enough of this in the Trump case?

Was the Senate ever told, when John Brennan was up for CIA director under President Obama, that Brennan had voted communist in 1976? Did the FBI uncover that fact in its background investigation? We know that the Senate voted to confirm him by a 63-34 vote. Even then-Senator Dan Coats, now Trump's Director of National Intelligence, had voted to confirm Brennan. Other Republican "yes" votes included Richard Burr, Susan Collins, Bob Corker, Jeff Flake, Lindsey Graham, Orrin Hatch, and John McCain.

Conservative public interest attorney Larry Klayman suggests that Kavanaugh and his accuser take polygraph examinations from a reputable independent polygraph examiner. This makes some sense. But the other person said to be in the room, Kavanaugh friend Mark Judge, should also take one. However, he has hired a lawyer and has refused to testify under oath on Kavanaugh's behalf.

If we truly want to get to the bottom of this mess and understand what really drives Kavanaugh, consider the falsehoods told by his main character witness and former boss, Ken Starr, whose new book *Contempt* claims that Foster "parked his car" at Ft. Marcy Park and "pulled out a pistol that had been in his family for two generations" and shot himself. None of this is true. The car was not Foster's and the gun was not his. But a variation of this cover story is what Kavanaugh, under orders from Starr, put into his final report. Kavanaugh has told the Senate Judiciary Committee that his report on Foster's death has "stood the test of time," a completely bogus claim.

Dear Mr. McGahn:

As you know, serious and credible allegations of sexual assault and attempted rape have been brought against Judge Brett Kavanaugh, whose nomination to the United States Supreme Court is pending before the Senate. As White House Counsel, you have overseen the Trump Administration's efforts to name and confirm judicial nominees. You accompanied Judge Kavanaugh to his meetings with Senators on Capitol Hill and sat behind him on each day of his confirmation hearings before the Senate Judiciary Committee. The betting at this point is that Trump will probably get Kavanaugh confirmed and then lose the House and Senate. He will get no more Supreme Court picks confirmed. By then, McGahn will have left the White House and returned to his firm Jones Day, which is representing Catholic cover-up artist Cardinal Donald Wuerl. This part of the Swamp, which includes the Catholic hierarchy and Georgetown Prep, counts Kavanaugh as a proud member in good standing. They will protect their party boy and will have a lot of leverage over him.

On the court, Kavanaugh will vote to protect abortion rights and homosexual rights as "settled law." Conservatives will lose again.

The Kavanaugh Fiasco and the Current Crisis

Conservatives who backed Judge Brett Kavanaugh without examining his record are looking like complete fools. Before the sexual assault charges surfaced, he was already on record saying the atrocious Supreme Court decisions on abortion-on-demand and "gay marriage" were "settled law." Now, his character is under assault as questions surface about the party atmosphere and secular nature of his Jesuit-run Catholic high school. Catholic "education" has become another crisis.

Kavanaugh Accuser Comes Forward, Saying He Pinned Her on Bed and Groped Her

Republican presidents can make big mistakes, and Kavanaugh has clearly been another one. Remember that President Ronald Reagan made a mistake when he nominated another liberal Catholic, Anthony Kennedy, to the Supreme Court. "Judge Kennedy represents the best tradition of America's judiciary," Reagan had said at the time. In fact, Kennedy turned out to be a liberal activist judge on "gay marriage" and even abortion, leading to culture wars which accelerated under former President Barack Hussein Obama into a push for "transgender" rights.

At the White House ceremony where his nomination was announced, Kavanaugh praised his liberal mentor Anthony Kennedy for "securing liberty," a bizarre claim for a judge who has been sold as a constitutional conservative. It's the kind of statement that leads one to conclude that Kavanaugh would find "transgender rights" in the Constitution as well and that Obama's "Permanent Revolution" will continue.

On the offensive, as usual, Rep. Joe Kennedy (D-Mass.) chairs the Transgender Equality Task Force in Congress and is backing transgender Democratic candidate Christine Hallquist's run for Governor of Vermont. Meanwhile, Democratic Rep. Kyrsten Sinema, the only openly atheist and bisexual member of Congress, is running for the Senate in Arizona.

In the face of this assault, questions persist about Kavanaugh's record on religious rights. I interviewed attorney Arthur A. Schulcz, Sr. on America's Survival TV about Kavanaugh's rulings against Evangelical and Pentecostal Chaplains in the military services. A case can be made that Kavanaugh's rulings suggest a governmental

preference for one religion, in violation of the establishment clause, and deference to the Vatican hierarchy from the bench. Before the sex scandals undermined his mission, the Roman Catholic church under Pope Francis had become a major force for the global left. Kavanaugh was a member in good standing of a major liberal parish in the fancy neighborhoods of Washington, D.C. and Chevy Chase, Maryland, catering to the liberal elite.

What we know for sure is that Brett Kavanaugh is not a conservative Catholic like the late Antonin Scalia. It was Justice Scalia, a good Catholic, who had decried the make-up of the Supreme Court as elitist and out-of-touch with ordinary Americans. He noted that they were lawyers who studied at Harvard or Yale Law School and that, "Not a single evangelical Christian (a group that comprises about one quarter of Americans, or even a Protestant of any denomination."

Catholics are 25 percent of the population but make up more than half of the Supreme Court. (Justice Neil Gorsuch was raised Roman Catholic and attended the same elite Jesuit-run high school as Kavanaugh but now reportedly attends an Episcopal Church.)

A true Catholic who believes in church teachings on human life and human rights would reject the hierarchy and demand resignations from Jesuit Pope Francis on down. Did Kavanaugh, a former altar boy, volunteer as a lawyer to seek justice for the innocent young ones whose lives were destroyed by predator priests? That's called *pro bono* work in the legal profession. If he did, we see no record of this in his Senate confirmation hearings. Did he object to the Pope's left-wing drift? Again, we see no evidence of that.

Instead, Kavanaugh's claim to fame is that he coached a Catholic girls' basketball team. He even brought members of the team to his confirmation hearings. It was a nice touch but totally irrelevant to whether he is qualified to be a judge. In retrospect, his decision to surround himself with members of the girls' basketball team he coached looks like an attempt to give his record a pro-woman veneer. Did he think his past would come back to haunt him?

We now see evidence that he was a party boy at his Jesuit-run high school, Georgetown Preparatory School, and allegations that he was "stumbling drunk" when he tried to assault a young woman. Knee-jerk supporters of Kavanaugh are claiming the woman, now a professor, is a far-left activist. But the other young man supposedly in the room with Kavanaugh and the young woman is not reassuring in his denial.

That Kavanaugh friend, identified as Mark Judge, has written a book with the title, *God and Man at Georgetown Prep: How I Became a Catholic Despite 20 Years of Catholic Schooling.* The official description is as follows: "In this account, the author explores the role of Catholicism in Catholic institutions, presenting three Catholic universities and discussing their lack of religious conviction, arguing for more Catholic theological education and less secularism." The author also wrote, *Wasted: Tales of a Genx Drunk,* with a review declaring that Kavanaugh's friend was grateful to Alcoholics Anonymous

"for helping him get his life together" and that "he wonders, appropriately, why the trendy priests and teachers at some of America's most prestigious Catholic institutions didn't help him steer a better path."

This does not bode well for another Catholic from the same school on a Catholic-dominated court. Mark Judge does not sound like a good character witness.

Trump is limited to two four-year terms, assuming he survives impeachment and is reelected. However, the battle over the Supreme Court is about whether Trump can reverse Barack Hussein Obama's legacy through Supreme Court nominees who will be on the court for decades. Our book, *Permanent Revolution: The Secret Life and Legacy of Barack Hussein Obama*, describes how Obama stacked the courts with his radical "progressive" judges, who are systematically dismantling America's Judeo-Christian heritage.

In this titanic struggle, one's character is critical. But it was Kavanaugh, as a young prosecutor working under Independent Counsel Ken Starr, who helped engineer a cover-up in the Vincent Foster death probe, which was part of the overall Clinton investigation, when he concluded that the former Clinton Deputy White House counsel killed himself. Among other things, as witness Patrick Knowlton testified, Foster's car was not at the park when he died. What's more, the gun in Foster's hand was not his, and his fingerprints were not on the gun. President Trump once called the death "fishy," and he was right.
