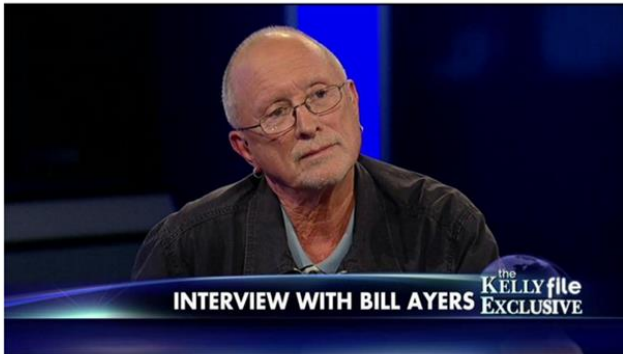
Hello boys! Newsreader Megyn Kelly goes from Fox to foxy as she strips off for magazine shoot

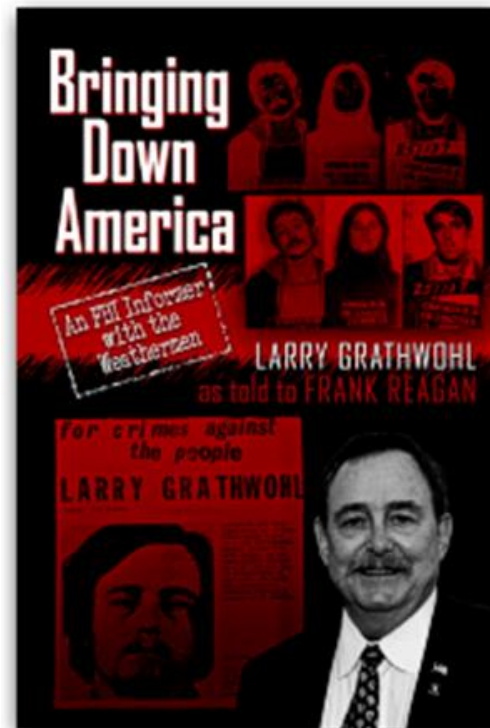
Ayers Smearred FBI Informant Larry Grathwohl, who passed away last year and could not defend himself.

KELLY: SDS was the precursor to the Weather Underground.

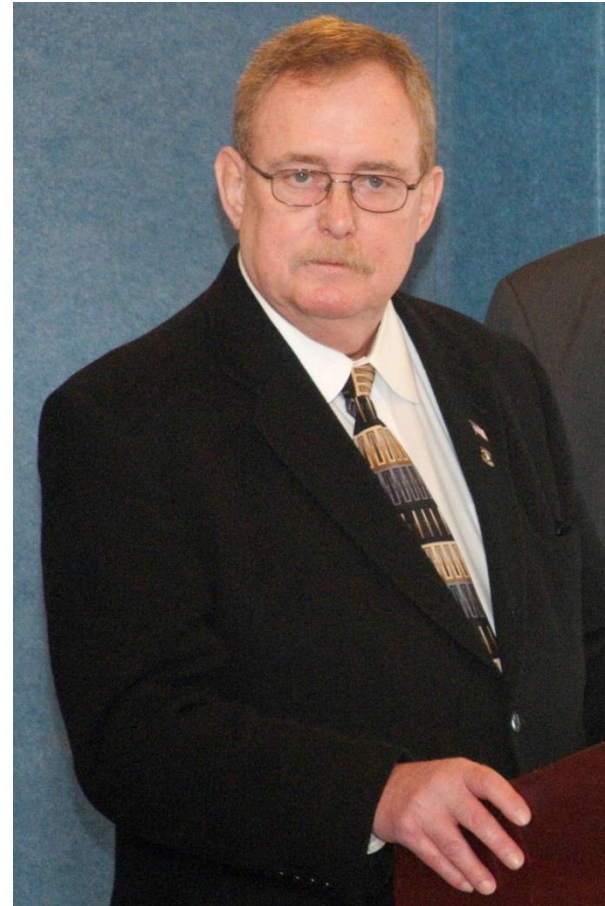
AYERS: Yes, it was the student movement, exactly. And no, **Larry Grathwohl was lying and the police union doesn’t know what they’re talking about.**

Ayers talked repeatedly on the show about U.S. involvement in a “genocidal” war and 6000 being murdered by U.S. forces every week. These were some of the most outrageous and objectionable claims. None was rebutted on the show.

Larry Grathwohl joined the Army in 1964, wanting to go to jump school and be assigned to the 101'st Airborne Division. He got his wish and was assigned to the 2/502 Infantry and was sent to Vietnam in July of 1965. After completing his tour he was assigned to Ft. Knox, Kentucky, and became a Drill Instructor. Upon receiving an Honorable discharge, and while attending the University of Cincinnati, he was recruited by the Cincinnati Police to infiltrate the Weathermen. He would later be working for the FBI and become the only person to go underground with what became known as the Weather Underground. After his cover was blown, he testified before several Federal Grand Juries, the U.S. Senate and at the Mark Felt/Ed Miller FBI trial. He wrote the 1976 book, *Bringing Down America* (with Frank Reagan), detailing his experiences.

This "wanted" poster for Larry Grathwohl was circulated by the Weather Underground. Copies were seized by FBI agents in a raid in the San Francisco Bay area.

Sgt. Brian V. McDonnell was a victim of the Weather Underground's Park Police Station bombing on February 16, 1970. He caught the full force of the flying shrapnel. (He died from his injuries two days later). This case, featured on the "Kelly File" show interview with Bill Ayers, can still be solved and indictments can be brought, despite Megyn Kelly's erroneous statements to the contrary.

FACT CHECK

Kelly: “Ayers and Dohrn might also be in jail today but the FBI broke the law in pursuing them, and in the end no case was brought.”

FACT: The Park Police Station bombing case is still active.

Kelly: “You and your group were calling for more violence, what we saw in February of 1970, February 16th was San Francisco police officer Brian McDonnell, a 44-year-old father of two and husband, was killed when a bomb went off at his police station and eight other police officers were injured in that blast. Now, your wife Bernardine Dohrn has been accused of that crime. Do you deny it?”

Ayers: “Absolutely deny it. Absolutely nothing to do with it.”

Grathwohl: “When he [Bill Ayers] returned, we had another meeting at which time—and this is the only time that any Weathermen told me about something that someone else had done—and Bill started off telling us about the need to raise the level of the struggle and for stronger leadership inside the Weathermen ‘focals’ [cells] and inside the Weatherman organization as a whole. And [what] he cited as one of the real problems was that someone like Bernardine Dohrn had to plan, develop and carry out the bombing of the police station in San Francisco, and he specifically named her as the person that committed that act.”

Dear Mr. Kincaid:

Sgt. Brian McDonnell of the San Francisco Police Department was murdered by urban terrorists on the night of Monday, February 16, 1970.

Sgt. McDonnell was in uniform and on duty at Park Police Station when a bomb placed near a window of the station exploded and forever changed the lives of many, many people.

Though Sgt. McDonnell was the sole fatality of this heinous and cowardly act, several other police officers fell victim to this incident of terror and were seriously injured as well. These officers include Ronald Martin; Al Arnaud; Robert O'Sullivan; Gerald Doherty; Ed Buckner; Robert Fogarty; Frank Rath and Sgt. Paul Kotta.

Those responsible for the cold blooded murder of Sgt. McDonnell and the injuries to the other officers have never been brought to justice and the case remains open.

There are irrefutable and compelling reasons to believe that Bill Ayers and his wife Bernadine Dohrn, members of the terrorist group "Weather Underground" are largely responsible for the bombing of Park Police Station and other police stations and police facilities throughout the United States during their "tour of terror" in the late 1960's and early 1970's.

The San Francisco Police Officers' Association also strongly urges that every possible effort be made to bring all evidence concerning this crime and all other crimes of urban terrorism perpetrated by the "Weather Underground" against the police officers of our great country to the forefront in a court of law.


**Facts about the Park Station case missing from the “Kelly File.”
The bomb contained heavy metal staples and lead bullets.**




SFPOA: “Officers Martin and Arnaud, who were standing several feet from the window ledge, were knocked to the ground and sustained injuries from the flying glass. The bomb caused Officers Doherty and Buckner to suffer hearing impairment and shock. Sergeant Kotta was knocked to the floor of the assembly room unconscious. Officer Fogerty had suffered multiple severe wounds on his face, cheek and legs from the flying fragments and glass. Officers O’Sullivan and Rath were also injured by the flying pieces of debris.”

Bernardine Dohrn: “I didn’t have anything to do with it... What Grand Jury?” Dohrn served seven months in jail for refusing to cooperate with the federal grand jury investigating the robbery in which two policemen and a Brinks guard were killed.

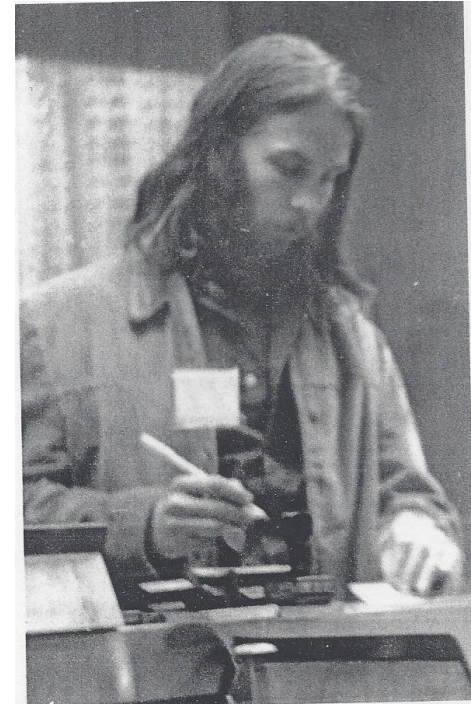
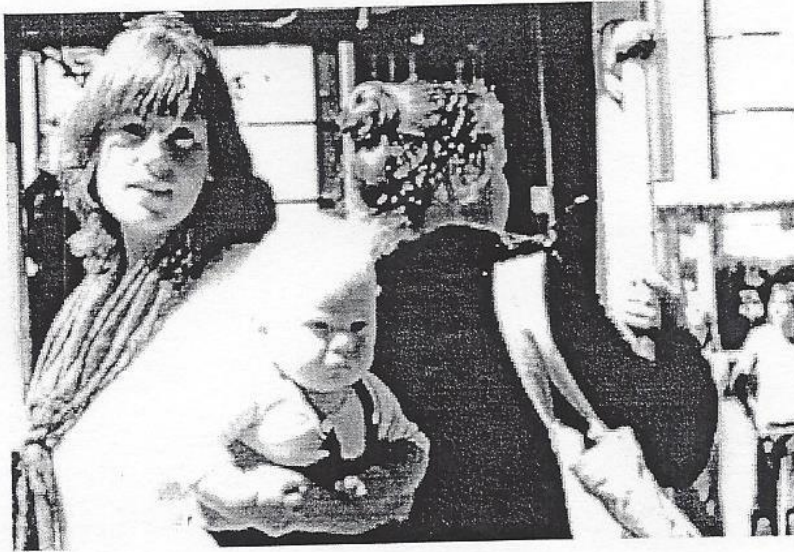
Kelly failed to mention that Ayers' fingerprints were found in a Weather Underground bomb factory in San Francisco, where Sgt. McDonnell was killed.

[redacted] San Francisco, California. He stated that during April, 1970, one CLINTON EVERETT WILLARD rented the apartment for a year period ending March, 1971. At the time he claimed to be employed by Mr. EZRA HENDON, an attorney in Berkeley, California. When [redacted] arrived at the building in mid-April, 1971, he discovered the apartment apparently abandoned. On inspection he discovered bombing paraphernalia which led him to contact the FBI.

[redacted] viewed photographs of various WUO members and identified photographs on California drivers licenses in the names CLINTON EVERETT WILLARD and ROBERT PEARSON WHITE as being identical to the man who rented the apartment. (Both the WILLARD and WHITE drivers licenses had come to the attention of the FBI in previous investigation insofar as both individuals in whose names these licenses were issued died as infants.) [redacted] also identified a photograph of WUO member CLAYTON VAN LIDEGRAF as being identical to the older man who helped to move "WILLARD" into the apartment. (On May 20, 1971 [redacted] Kent State University, Kent, Ohio, was shown the WILLARD and WHITE drivers licenses and advised that both bore the photograph of MARK JOSEPH REAL, whom he knew to have been the WUO leader in the Kent area in late 1969.)

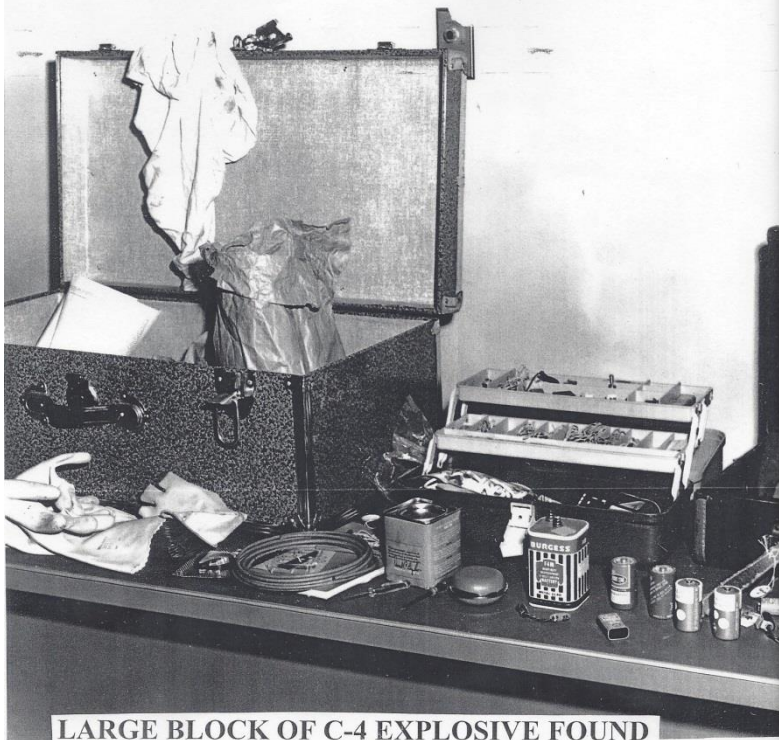
Inspection of the apartment yielded an amount of explosives and bomb making paraphernalia. Fingerprints were subsequently lifted from articles in the apartment by Special Agents of the FBI. Fingerprints of the following WUO members were found in this apartment:

who were sympathetic to the Cuban Revolution. Venceremos was a Spanish slogan used by Ché Guevara, meaning “We shall overcome.” The brigades were organized as work forces to help the Cubans harvest their sugarcane crop. Because the U. S. restricted direct travel to Cuba, members of the brigades had to take devious routes to reach their destination. Some traveled to Canada and then by boat to Cuba, while others went by way of Mexico. Weathermen seized the opportunity of going to Cuba. Not only could they actually work for a successful revolutionary government, but once in Cuba they had the opportunity to get professional training in weapons and guerrilla tactics. When Naomi was in Cuba, she was trained in the use of sophisticated weapons such as the AK47 machine gun and was given assurances that any serious revolutionary group in the U. S. would get help when it was needed.

(11) In 1964, Kathy Boudin was invited by the Cuban Mission to the United Nations (CMUN) to attend a Cuban July 26th celebration. (12) She spent her senior year of college at Moscow University, Moscow, U.S.S.R. (1964-65). (13) Boudin went to the U.S.S.R. on her own and not through any special student program. While in the U.S.S.R. she received 75 rubbles per month from the Russian government as a stipend.

A person known by the FBI to be maintaining a covert relationship with the Soviet Intelligence Service (SIS) was active in the SDS in 1969. This person acted as a spotter for SIS. An influential figure in this person's life was a former CPUSA member who also maintained a similar covert relationship with SIS. (200)

The FBI knew that Cuban officials provided a communications link for the Weathermen after they went underground. The Weathermen had several Canadian telephone numbers through which they could contact one another. If contact could not be made through these numbers, the instructions were for the caller to phone the Cuban Embassy in Canada and by use of a Weatherman code, leave his name, whom he wanted to contact and where he could be reached. The Weatherman code was simply to use the true first name but always to use the alias Delgado for the last name. (670)

Cliff Kincaid letter to Roger Ailes of Fox News:

The Ayers appearance on Fox News is a terrible precedent which constitutes the rehabilitation of a communist terrorist, setting the stage for President Obama to use his pardon power to release some of Ayers' comrades from prison. Indeed, Weather Underground terrorist Linda Evans, who was pardoned by President Clinton and released from prison, recently spoke at a pro-Castro event in Washington, D.C. and talked openly of a campaign to get other terrorists released from prison.

In fact, Obama's Attorney General Eric Holder was deputy attorney general in the Clinton administration and was involved in pardons for members of the Puerto Rican FALN and the Weather Underground, including Evans. Under Obama, the Holder Justice Department granted early release to Weather Underground terrorist Marilyn Buck.

What is needed in Park Police Station case:

- Forensic reexamination of bombs (for fingerprints, etc.) and bomb debris.
- Track down Weather Underground support people.
- Tools and materials discovered at Pine Street bomb factory can be re-tested.

Statement of Ronald Martin, one of the police officers injured in the February 16, 1970 bombing of the Park Police Station in San Francisco

My name is Ronald Martin, and I was one of the police officers injured in the February 16, 1970, bombing of Park Station. The blast took the life of my fellow officer, Sergeant Brian V. McDonnell. It is important for justice to be done in this case and that the killer or killers be pursued, charged, and prosecuted. There is no statute of limitations on murder, and I believe that federal authorities should work more closely with those on the local and state levels to make sure justice is done in this case. That is why I want to support the effort of Cliff Kincaid and his America's Survival, Inc. organization to focus public attention on this matter and increase the pressure on those in Washington, D.C. for this "cold case" to be investigated and solved.

Over the years we have heard various accounts about who was responsible. The possible culprits include members of the Weather Underground and the Black Liberation Army. Former FBI informant Larry Grathwohl testified that he heard Weather Underground member Bill Ayers himself say that Bernardine Dornh was responsible for the bombing. I am not sure who was responsible. Perhaps it was a combination of members of both groups, since we know that they worked together on occasion.

It has been a long time since the bombing. But the charges in 2007 filed against members of the Black Liberation Army for the murder of Police Officer John Young in 1971 demonstrate that "cold cases" can be solved. I am concerned, however, by the change in national administrations and worry that political considerations stemming from President Obama's personal relationships with Weather Underground members Bill Ayers and Bernardine Dornh could prove to be a complicating factor in going forward in the Park Station bombing case. A statement or expression of support from Attorney General Eric Holder for getting to the bottom of the Sgt. McDonnell murder would go a long way toward reassuring some of us that politics will not be a consideration in seeking justice. He could also reassure FBI Director Robert Mueller that he wants and expects justice in this case.

The effects of some of my injuries are still with me 39 years later. But while I was injured by the blast, I was not harmed by the heavy metal staples that were packed inside the bomb. I was protected from their impact by a police car outside the station. The nature of the bomb is important to take into account because it was deliberately designed to hurt or kill police officers. Those staples ripped through Sgt. McDonnell, causing his death. How can we rest as long as his killers are free?

It has been a long time since the bombing. But the charges in 2007 filed against members of the Black Liberation Army for the murder of Police Officer John Young in 1971 demonstrate that “cold cases” can be solved. I am concerned, however, by the change in national administrations and worry that political considerations stemming from President Obama’s personal relationships with Weather Underground members Bill Ayers and Bernardine Dohrn could prove to be a complicating factor in going forward in the Park Station bombing case. A statement or expression of support from Attorney General Eric Holder for getting to the bottom of the Sgt. 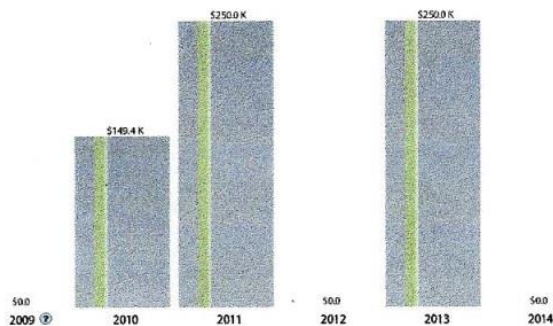

Group Headed By Weather Underground Terrorist Gets DOJ Grants

Judicial Watch

The Justice Department has awarded a group headed by a domestic terrorist and one-time FBI fugitive with close ties to President Obama hundreds of thousands of dollars to reduce racial disparities in the juvenile justice system.

This is a story you likely won't see in the mainstream media, but a conservative political magazine exposed it this week. The Department of Justice (DOJ) has given \$400,000 in grants to an organization (W. Haywood Burns Institute) that blames disproportionately high criminal behavior among minority juvenile delinquents on discrimination. The San Francisco-based nonprofit describes itself as a leading organization in the field of juvenile justice and ethnic and racial disparities reduction.

It declares her a suspect in the murder of Sgt. Young.

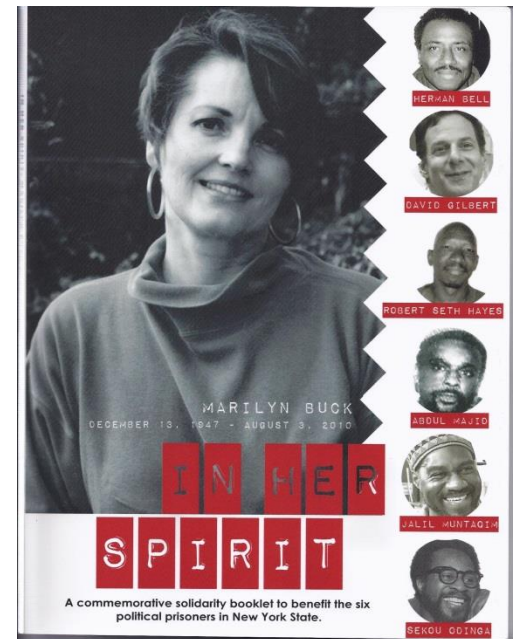

BUCK is also suspected of having assisted the BPP - CF in other activities in the San Francisco area. Inspector [REDACTED] advised that while attempting to interview [REDACTED] SF 100-62582, stated that she knew of the Ingleside shooting and that she was not involved but that MARILYN BUCK was.

Kelly: This is your sweetheart? This is your soul mate?

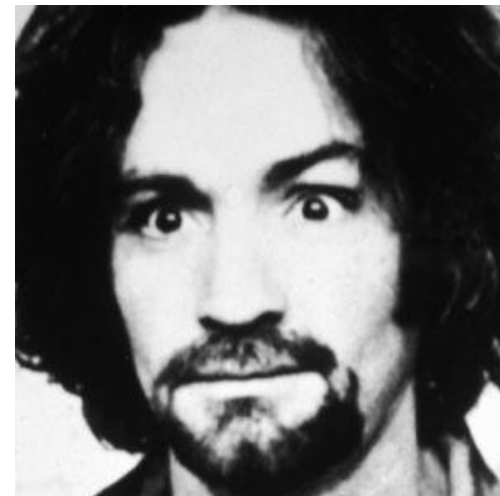
Ayers: No, no, no. This is nonsense. And this is something again that gets re-circulated.

Kelly: **That's not how the New York Times reported it.** The New York Times reported it exactly as I put on the board. Did they lie too?

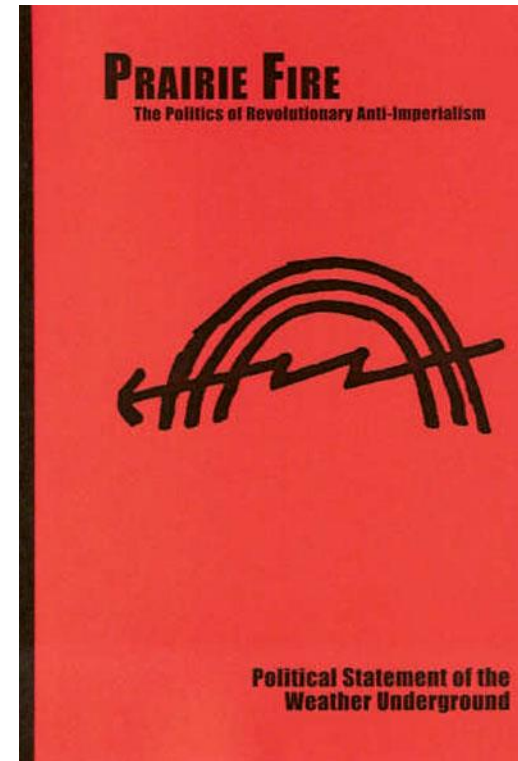
Ayers: **The New York Times, they lie daily, are you kidding?**

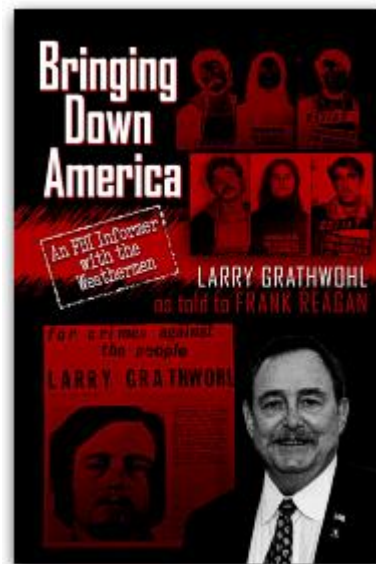
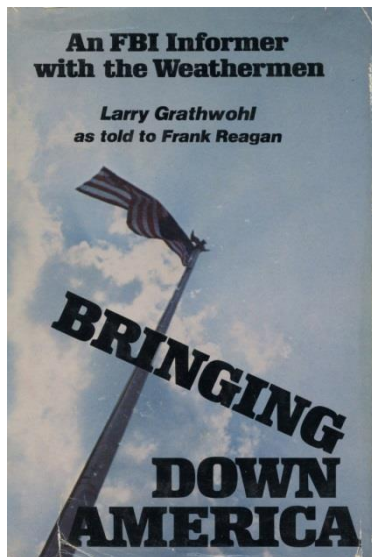
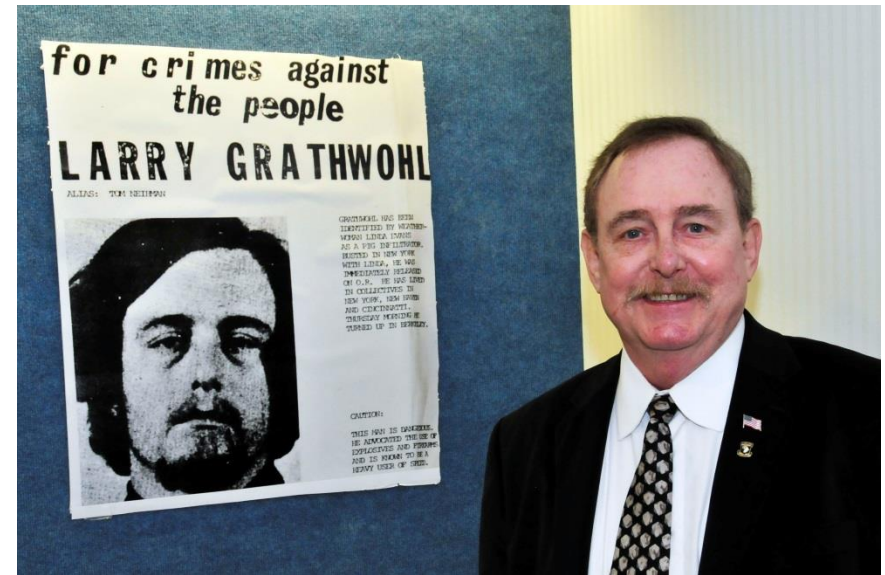


In fact, Sirhan Sirhan was a fanatical Palestinian who killed Robert F. Kennedy because Kennedy was a supporter of Israel. The assassination occurred on the first anniversary of the Six Day War in which Israel defeated the armies of its Arab neighbors. What's more, Sirhan's diaries include the repeated phrases, "RFK must die," and "long live communism."

Dohrn, perhaps more notorious than Ayers, had praised the mass murdering psychopath Charles Manson as a true “revolutionary.” Manson had taken a group of young people, subjected them to heavy drug use, and ordered them to commit murder. This modus operandi was evident in the activities of the Weather Underground itself, whose members used illegal drugs, practiced group sex and homosexuality, and engaged in violence and murder. The Weather Underground helped LSD advocate Timothy Leary escape from a federal prison in September 1970.
