

# The Communists, Globalists, Terrorists and Fellow Travelers Trying to Jail President Trump

Katy Chevigny, the wife of anti-Trump "Special Counsel" Jack Smith, produced a fawning "documentary" about Michelle Obama. But there is more – far more. It turns out that Katy Chevigny's parents are linked to an assortment of communists, socialists, and terrorists. And these facts make her family into even more of an interesting phenomenon shedding light on why Jack Smith (under the direction of Biden Attorney General Merrick Garland) is trying to put former President Trump in prison and tie him up in court during the 2024 presidential campaign.

**Jack Smith is a veteran of the Obama Justice Department who went to work for the U.N.'s International Criminal Court while Katy Chevigny is a well-known Democratic Party operative and contributor to Joe Biden's campaign. Her Michelle Obama Netflix film, "Becoming," is based on Michelle Obama's book by the same name.**

In Washington, D.C. parlance, they are a "power couple." There is a photo of Jack Smith (real name "John Smith") wearing a shirt with his wife's production company name, "Big Mouth Productions." So he's clearly on board with her partisan predilections, as his work for Biden and Merrick Garland already attest.

Their goal: destroy Trump and elect Biden and/or (if necessary) replace him with Michelle Obama or some other Democrat.

**Katy Chevigny is not necessarily a red diaper baby. But the facts surrounding her parents, Paul and Bell, who undoubtedly influenced their daughter, are shocking and worthy of further investigation. And her marriage to Jack Smith, who worked for the United Nations' International Criminal Court and the European Union's Kosovo Tribunal, adds to the intrigue.**

What we can say for sure is that the political activities of this "power couple" demonstrate that Trump is a major threat to the United Nations and its affiliated global courts and institutions, as well as the international communist movement.

The facts about the Smith/Chevigny team help explain why communists are fearful of Trump's return to the presidency. The Communist Party USA paper the People's World notes with trepidation that Trump has said that "communists," "socialists," and "Marxists" had combined as "a powerful force" targeting him and plotting the downfall of the United States.

**The CPUSA and other communist groups fear that Trump will investigate communists on American soil and deport them.**

What better way to nip this effort in the bud than to stop Trump from regaining the presidency?

Speaking to the Faith & Freedom Coalition conference, President Trump said, "Using federal law, section 212 (f) of the Immigration and Nationality Act, I will order my government to deny entry to all communists and all Marxists. Those who come to join our country must love our country. We don't want them if they want to destroy our country.... So, we're going to be keeping foreign Christian-hating communists, socialists, and Marxists out of America. We're keeping them out of America."



A writer for the Communist Party newspaper admitted that Trump said, accurately, that the law already "prohibits the entry of communists" into the U.S. Federal immigration law does indeed say that any immigrant "...who is or has been a member of or affiliated with the Communist...party (or subdivision or affiliate thereof), domestic or foreign, is inadmissible."

But they are already here.

Trump understands this, asking, "But my question is, what are we going to do with the ones that are already here, that grew up here?" The communist writer reported that the packed auditorium erupted with screaming chants of "Deport them! Deport them!"

**A law intended to jail subversives, the Communist Control Act, is on the books [50 U.S. Code § 841](#). but no longer enforced by the Biden Justice Department.**

Let us look at the background surrounding the Smith/Chevigny cabal and their backers.

Based on appearances, Katy Chevigny is nothing more than a partisan Democrat, much like her husband Jack Smith, who started his legal career in the Justice Department of

Barack Hussein Obama. But her parents Paul and Bell are a different story.

**Terrorist Mentor Bell Chevigny**

Former prison “teacher” Bell Chevigny, who died in 2021, was a mentor for former Weather Underground terrorists Judith Cark and Susan Rosenberg when Chevigny ran PEN America’s Prison and Justice Writing Program and served as a George Soros senior justice fellow. All of this is admitted by the PEN program.

Bell Chevigny (BA, Wellesley College, MA, PhD, Yale University) was professor emeritus of literature at Purchase College, State University of New York. After she retired, the School of Humanities honored her by establishing the Bell Chevigny Prize for Feminist Studies in the Humanities.

**We published a report on how billions from Soros have funded communist and legal groups. It cites collaboration between the communist front National Lawyers**

**Guild (NLG), the ACLU, the American Constitution Society, and the Council on American-Islamic Relations (CAIR).**

Bell Chevigny's book, *Doing Time: 25 Years of Prison Writing*, features writings from criminals, but she is also known for writing a May 18, 2003 letter to the New York Times supporting parole for Weather Underground terrorist Kathy Boudin, who was convicted of murder and robbery in a 1981 armored-car heist in Nyack, New York, in 1981.



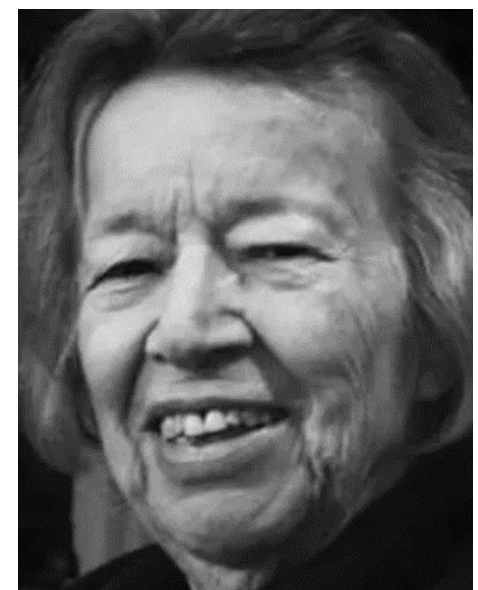
Paul Chevigny filed suit against the New York City "Red Squad," which monitored such groups as Youth Against War and Fascism.

The terrorist group received terrorist training in Communist Cuba and was advised by Soviet and Cuban intelligence agents.

Rebutting the assertion by the New York Parole Board that Kathy Boudin's crime outweighed her "remarkable programming and disciplinary record," Chevigny wrote, "Hundreds of prisoners in the PEN Prison Writing Program, of which I am chairwoman, demonstrate that writing can be richly rehabilitative. Finding in writing, she says, 'a path toward facing past tragedies,' Ms. Boudin has also taught her fellow inmates courses in literacy and parenting and helped shape the college-bound and AIDS counseling and education programs. If Ms. Boudin does not merit parole, who does?"

Others supporting parole for Boudin included communist historian Howard Zinn, Marxist Noam Chomsky, and her son Chesa Boudin, who insisted,

"She is consistently and deeply remorseful. There is no further public safety interest and no purpose served by continuing to incarcerate my morn. She has overcome countless obstacles to become a loving, caring mother. She is one of the most amazing people I have ever met and I can not imagine a person with a deeper commitment to respect, kindness, honesty, and responsibility."

"Ms. Boudin was unarmed," declared Bell Chevigny, refusing to admit her deep role in the heist.

Here is the background: the Weather Underground had launched an armored-car robbery that left two Nyack, New York police officers -- Officer Waverly Brown and Sergeant Ed O'Grady -- mortally wounded. In addition, the Brinks armored-car driver, Peter Paige, was also shot to death by the Weathermen.

**Declassified information [published](#) by America's Survival, Inc. (below) shows that Kathy Boudin, who received a BA from Bryn Mawr College, attended Moscow University and was subsidized by the Soviet government. Her father was a CPUSA member and a registered Cuban agent, documents show.**

(9) For example, Kathy Boudin's father was a member of the Communist Party U.S.A. (CPUSA) and a registered Cuban agent. (10) He was named in a prepared briefing on espionage and subversive activity given to President Eisenhower and others at a National Security Council meeting in 1956. (11) In 1964, Kathy Boudin was invited by the Cuban Mission to the United Nations (CMUN) to attend a Cuban July 26th celebration. (12) She spent her senior year of college at Moscow University, Moscow, U.S.S.R. (1964-65). (13) Boudin went to the U.S.S.R. on her own and not through any special student program. While in the U.S.S.R. she received 75 rubbles per month from the Russian government as a stipend. (14) Her father also sent her materials on the American Youth Festival which was to be held in Algeria while she was in Russia, and told her that while in Prague he was told that if she wanted to attend as an interpreter, it could possibly be arranged. Kathy Boudin and David Gilbert of the Weather Underground went to prison for their roles in the Nyack assault. Gilbert co-authored the SDS booklet, "U.S. Imperialism,"

whose first page includes a quote from the Communist Manifesto. He wrote the book, *No Surrender: Writings from an anti-imperialist political prisoner*, which includes an endorsement on the back cover from Ward Churchill, the disgraced college professor who achieved notoriety for comparing 9/11 victims to Nazis.

Chesa Boudin, the product of David Gilbert and Kathy Boudin, was the adopted son of the Weather Underground terrorists Bill Ayers and Bernardine Dohrn. He became the San Francisco district attorney but was recalled over his soft-on-crime policies.

Chesa Boudin lived in Venezuela and became a self-described “foreign policy adviser” to Marxist ruler Hugo Chavez, who supported the Colombian FARC communist terrorists and Middle Eastern terror groups.

By his own admission, Ayers had traveled four times to Venezuela to lecture on “educational” issues. He was described by Venezuelan authorities during one appearance as a former leader of a “revolutionary and anti-imperialist group” that “brought an armed struggle to the USA for more than 10 years from within the womb of the empire.”

### **Bernardine Dohrn was jailed for seven months for refusing to cooperate with a federal grand jury investigating the murders at Nyack.**

Ayers, Dohrn, Boudin and comrades were not “anti-war activists.” They were international terrorists who favored a communist victory in Vietnam and had connections to Hanoi, Havana, and Moscow. They advocated a foreign ideology that the Black Book of Communism says has killed about 100 million people.

Former FBI informant Larry Grathwohl presented evidence to a grand jury and the U.S. Senate that Weather Underground terrorists Bill Ayers and Bernardine Dohrn were involved in the 1970 bombing murder of San Francisco Police Sergeant Brian V. McDonnell.

Yet, Kathy Boudin was granted parole from a New York state prison in 2003 and died on May 1, 2022, at age 78.

A “Kathy Boudin Freedom Fund” was established in her honor by the Columbia University Center for Justice and is funded in part by the Soros-funded Open Society Foundations. Boudin had served as co-director and co-founder of the Center for Justice.

### **Fellow Traveler Paul Chevigny**

Paul Chevigny, a New York University law professor who died in 2023 and was a graduate of Yale University and Harvard Law School, was praised by the hard-core left as a “pioneering lawyer” for the ACLU who worked to end police surveillance of communist organizations based in New York City. Material collected by the New York City Police “Red Squad,” otherwise known as the Bureau of Special Services and Investigations (BOSSI), later known as the Special Services Division, examined such

groups as the Communist Party, Black Panthers, Nation of Islam, The National Renaissance Party (a neo-Nazi group), and Youth Against War and Fascism.

Chevigny was one of the original lawyers in *Handschu v. Special Services Division*, resulting in what the ACLU called “a restraint against inappropriate police surveillance of political groups.” The case is named for the lead plaintiff, Barbara Handschu, a former National Lawyers Guild vice president. IN 2017, she was one of over 200 lawyers, law students, legal workers and legal organizations [signing](#) a “letter in support of Palestinian prisoners on hunger strike in Israeli prisons.”

The NLG is currently supporting South Africa's case against Israel under the Genocide Convention, addressing “the ongoing plight of the Palestinian people in Gaza,” in a case before the U.N.'s International Court of Justice.

America's Survival, Inc. published a first-hand eyewitness report on the communist-organized “Free Palestine” rally in Washington, D.C. on November 4, 2023.

**Some of the “political groups” at issue in the Handschu case were supporting America's communist enemies. One photo in the official collection of intelligence information collected by the “Red Squad” showed American communists holding posters of Chinese Communist leader Mao.**

Chairman Mao's 1968 statement in “Support of the Afro-American Struggle Against Violent Repression” in the United States is significant in this regard. Mao had used the occasion of the Martin Luther King assassination riots in more than 100 American cities to declare that “The struggle of the Black people in the United States for emancipation is a component part of the general struggle of all the people of the world against U.S. imperialism, a component part of the contemporary world revolution.”

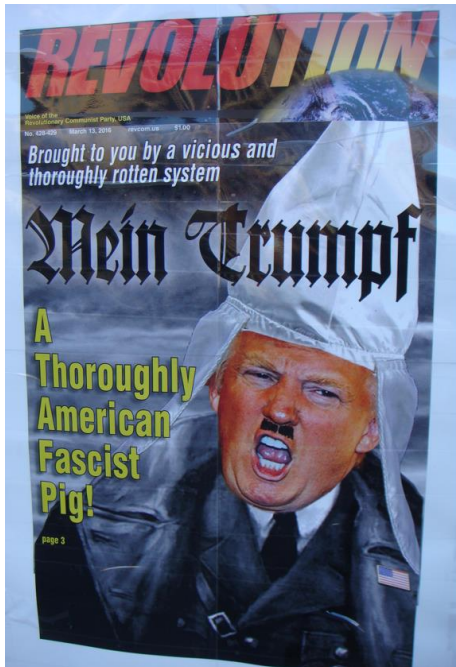
In other words, the Chinese Communists have been exploiting blacks to make America into a communist state. This wasn't just rhetoric. A 1973 congressional report on “America's Maoists” examined the Revolutionary Union and the Venceremos Organization. To cite one other example, American Maoist Bob Avakian started out with the SDS and the Revolutionary Union before running the Revolutionary Communist Party and setting up his own institute.

**Trevor Loudon’s KeyWiki site documents Paul Chevigny’s involvement in a 2002 “socialist scholars” conference, his role as a “speaker” for the communist front National Lawyers Guild and associations with various other communist fronts.**

He appeared on a panel, “The Imperialism of Human Rights?,” representing New York University Law School.

Other topics included “How Can the Marxist Theory of the State Help Us Understand the War Against Terrorism.”

Today, thanks in part to his legal efforts, communists run rampant in American cities, as we have seen with the communist-inspired anti-Israel “Free Gaza” protests closing roads and bridges in New York City and even threatening security around the White House . A communist bookstore run by the Revolutionary Communist Party (RCP) is based in Harlem.



**Smearing Trump as a Nazi is a favorite communist trick.**

Indeed, the RCP’s bookstore Revolution Books is the cutting edge of communist activity, leading the charge that former President Trump is a Hitler-like fascist – a claim adopted by the national Democratic Party.

**The group was started by “Chairman Bob” Avakian, a one-time comrade of Bill Ayers and Bernardine Dohrn who is on social media platforms Substack, Instagram, Facebook, X, Telegram, Threads and YouTube.**

The RCP bookstore hosted a party and celebration for a 91-page book called Constitution for the New Socialist Republic in North America. A used book sale at the bookstore included regular communist literature, as well as Bernie Sanders’ *Our Revolution*.

### **All in the Family**

As noted, Paul and Bell Chevigny are the late parents of the aforementioned Katy Chevigny, wife of Jack Smith, the Special Counsel. In addition to his work for these global entities, Smith is accused in a federal whistleblower complaint of facilitating an extortion scheme while serving as an international prosecutor.

The complaint will go nowhere unless Trump is elected and able to replace Attorney General Merrick Garland.

The names of Paul and Bell Chevigny appear on [a 2002 petition](#), after the 9/11 terrorist attacks on America, opposing American involvement in the Middle East and denouncing



the Israeli “occupation” of the West Bank and Gaza. Along with other notables, such as Marxist Noam Chomsky and Communist Howard Zinn, they pledged to “resist the machinery of war and rally others to do everything possible to stop it.”

**With Jack Smith working to jail Trump and Katy Chevigny busy promoting Michelle Obama, investigative journalist Joel Gilbert argues that “it appears the way is being paved by Obama loyalists for an easy path for Michelle Obama to the White House.”**

Gilbert’s film and book on a possible Michelle Obama run for the White House are getting increased attention as the 2024 campaign gets underway. “What’s deeper is the argument that Obama’s people are about 80 percent of Biden’s staffers and Obama has been running the show for the most part anyway,” he says.

Weather Underground terrorist Mark Rudd (below) went on a book tour, trying to cash in on his bloody record. The bomb that killed three of his comrades when it accidentally exploded in a New York townhouse was an anti-personnel device intended for an Army dance at Fort Dix, New Jersey. Rudd admits that he was in favor of planting the bomb, saying that he wanted “this country to have a taste of what it had been dishing out daily in Southeast Asia...” What the U.S. had been trying to do was prevent a communist takeover of South Vietnam.



In our report on Obama’s personnel, we note, “No figure in the Obama Administration was more important than President Barack Hussein Obama himself. A Marxist with Muslim sympathies, Obama was never honest with the American people about his mentor, Communist Party operative Frank Marshall Davis, a member of the Soviet espionage apparatus in Hawaii who had been under investigation or surveillance for at

least 19 years. But Obama could not have ‘accomplished’ his objectives without fellow travelers.”

What is more, a high-level analyst for J.P. Morgan recently speculated that Biden will withdraw from the presidential race sometime between Super Tuesday and the November election and that his replacement will be named by the Democratic National Committee.

But whether it’s Michelle or somebody else, Barack Hussein Obama is running the show and his former vice-president, Biden, is clearly a front man, who nominated another front man, Attorney General Merrick Garland. Remember that the Republicans had blocked Obama’s nomination of Garland to the U.S. Supreme Court.

**Garland’s current job, including appointment of Special Counsel Jack Smith, is to keep Trump out of the White House so that the Democratic Party can consolidate its power as the leading socialist/communist organization in the “Free World,” through a process the Marxists call “Permanent Revolution.”**

As part of this process, Obama, a Marxist student of Russian agent and CPUSA member Frank Marshall Davis, left the presidency and met with Chinese Communist President Xi to plot the final phase. The Chinese press called it a meeting of “veteran cadre,” yet another indication that Obama’s Marxist experiment was being organized in cooperation with China and Russia. That meeting preceded the release of the China virus that killed 1 million Americans, produced \$10 trillion in debt, and enabled Democratic governors in swing states to accelerate illegal voting during the 2020 campaign.

**In addition to publishing three books on the political significance of the Obama presidency, my group America’s Survival, Inc. warned the Senate that Garland, then a federal judge, was implicated in a major cover-up involving a member of a Weather Underground spin-off by the name of Elizabeth Anna Duke.**

Bomb-making materials, stabbing instruments and communist books were found inside a Weather underground hideout. Bernardine Dohrn (below), a Weather Underground terrorist, was accused of planting a bomb that killed a San Francisco policeman. She was a close friend of Michelle Obama.



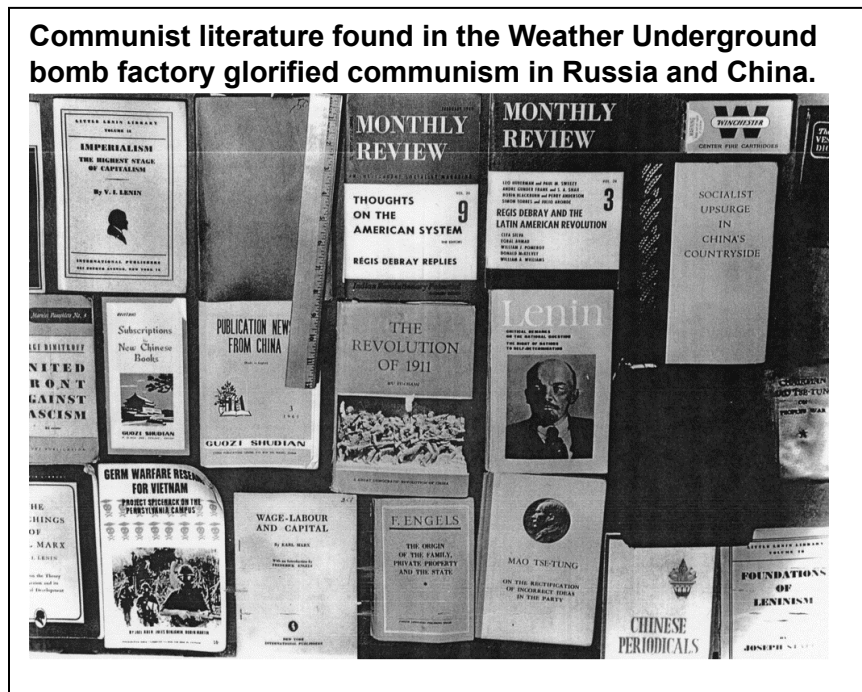
We had analyzed the issue of Merrick Garland's involvement in a court case brought by the Obama Administration to drop terrorism charges against Duke. She was a member of a Weather Underground spin-off that specialized in terrorism, including bombing the U.S. Capitol in 1983, and fake IDs. Then-Judge Merrick Garland found no problem with a magistrate who arbitrarily dropped the charges against her, at the request of Obama's Justice Department.

Gilbert's film reveals that Michelle worked closely with Bernardine Dohrn, the Weather Underground terrorist. From 1984-1988, Dohrn worked at Sidley & Austin, a law firm, which is also where Obama and his wife Michelle worked and met. "For three years after law school, Michelle worked as an associate in the area of marketing and intellectual property at Chicago law firm Sidley and Austin, where she met Barack Obama," the official Obama campaign website reported. But it said nothing about meeting or knowing Dohrn.

**Despite claims that Michele Obama is not political, Gilbert notes that she demanded that Trump be removed from social media and he was banned.**

The so-called Twitter files of internal communications by the company's executives between January 6-8, 2021, after the riot at the Capitol, cited "internal and external pressure," including from Michelle Obama, calling for Trump to be banned from using Twitter.

"Now is the time for Silicon Valley companies to stop enabling this monstrous behavior -- and go even further than they have already by permanently banning this man from their platforms and putting in place policies to prevent their technologies from being used by the nation's leaders to fuel insurrection," Michelle Obama wrote in a statement posted to Twitter on January 7.

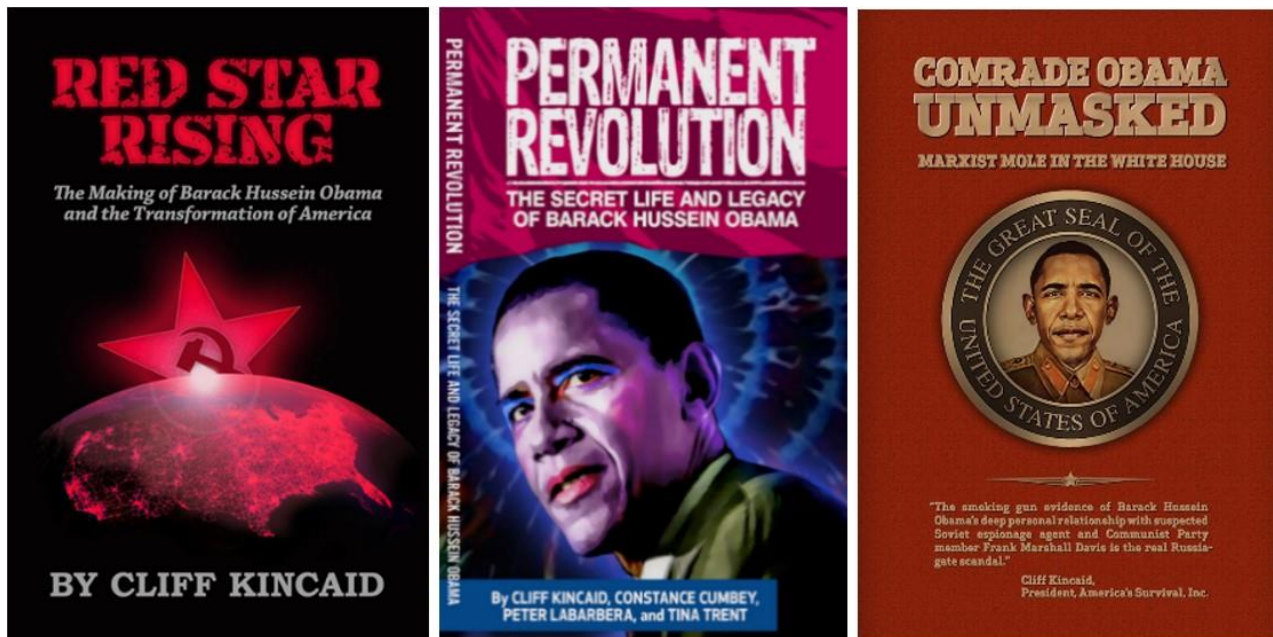


Monica Showalter, a writer for the American Thinker, commented: "Being good puppets for the Democrats, Twitter did as it was told, and banned the president of the United States, happily leaving Vlad Putin, the Taliban, Hezb'allah, Antifa, child porno purveyors, assorted child groomers, and Iran's mullahs to tweet their tweets without him."
