

“It is a battle against lies.”
**Stolen Elections, Murder,
Corruption and Deliverance**

If you do not accept the evidence that the 2020 presidential election was stolen, then you do not fully understand the “cartel” behind the corruption in government that wants to imprison former President Donald J. Trump.

This was among the messages of Dr. David Clements, an expert on election fraud, at a meeting of the Frederick County (Maryland) Conservative Club on April 25, as he linked the stolen election of 2020 to the imprisonment of January 6 protesters, many of whom went into the Capitol with a police escort, not knowing at the time they were being set up by federal and FBI informants in the crowd. One of the unarmed J6 protesters, Ashli Babbitt, was murdered by the Capitol Police.

Trump, who had urged peaceful and patriotic protests, was personally accused of waging the “insurrection” that was really being staged against him. This and other related bogus charges, such as “obstruction” of official proceedings, are now being pursued by various prosecutors against Trump, his former aides, allies, and more than 1,387 J6 defendants, directed by the FBI’s Washington Field Office. Approximately 520 have already been sentenced to prison.

(The obstruction charge focuses on efforts to block government proceedings by destroying a “record, document or other object” and the Supreme Court is expected to rule that it clearly doesn’t apply to the actions by Trump and others on January 6.)

We are living through a communist revolution. Literally dozens of communist groups operate on American soil, in open violation of the Communist Control Act, which is still on the books. (It was introduced by a Democrat, Senator Hubert Humphrey, and signed by a Republican president, Dwight Eisenhower.) The Marxist journal *Jacobin* [admits](#) that "...anti-communist laws remain on the books throughout the country" and that the Communist Control Act "has never been repealed..." The "cartel," as Clements calls it, is another word for the operations of what has been called the Deep State, a reference to U.S. intelligence agencies, especially the FBI, working in coordination with the national Democratic Party to silence and even outlaw conservative and Christian voices.

At the January 6, 2021, Save America Rally, President Trump had asked for peaceful protest, saying, "We have come to demand that Congress do the right thing and only count the electors who have been lawfully slated...I know that everyone here will soon be marching over to the Capitol building to peacefully and patriotically make your voices heard. Today we will see whether Republicans stand strong for integrity of our elections..."

At the rally, Trump had cited John Eastman, a constitutional attorney, as saying that Vice President Mike Pence could send the electoral certifications back to the states for review. In this way, Pence would follow the constitutional requirement. The Eastman

[memorandum](#) on this topic is legally and constitutionally sound but he is being persecuted as well. Eastman, a former professor and dean at the Chapman University School of Law, was searched and had his phone seized by the FBI and is now facing disbarment.

Journalist Allan Ryskind commented, “Trump’s purpose in his rally speech on the Ellipse south of the White House was not to start a riot, but to educate those going to the Capitol building why he believed he had defeated Biden.”

The J6 protesters were outraged at what they viewed as a national election being stolen, in the wake of news reports released at that time by the media that Pence had announced that he would NOT stop the illegal certification of Biden as president.

Though John Eastman’s legal memorandum on the 2020 stolen election was denounced as “fringe,” House Speaker Mike Johnson, a constitutional attorney, has noted the facts behind the illegal certification of Biden as the 2020 “winner.”

“President Biden was certified as the winner of the election, he took the oath of office, he’s been the president for three years,” he noted in an interview with CBS. “What the argument that we presented to the court, which is our only avenue to do so, was that the Constitution was clearly violated in the 2020 election. It is Article Two, Section One, and anyone can Google it and read it for themselves. **The system by which you choose electors to elect the president of the United States must be done by the individual states and the system must be ratified [by] the state legislatures,** that is language, plain language, in the Constitution...”

He went on to say, “Anyone who pulls up the Constitution on their smartphone, and reads Article Two [and] Section One of the Constitution has to agree with what I just told you. The Constitution was violated in the run up to the 2020 election, not always in bad faith, **but in the aftermath of COVID, many states changed their election laws in ways that violated that plain language.** That’s just a fact. We presented that argument and... those facts to the court, and it was never directly addressed because of the Texas litigation, but that was the only vehicle we had to present that issue squarely to the court.”

The latter was a reference to a lawsuit filed by Texas Republican Attorney General Ken Paxton challenging election results in various states because of illegal changes in election procedures, such as bypassing state legislatures to facilitate mail-in ballots that could not be verified. The Paxton lawsuit failed because of political pressures, not an alleged lack of legal standing. Our report “The Deep State Wears Black Robes” looks at the political pressures at work in the selection and conduct of Supreme Court justices and the “judicial supremacy” that produced illegal decisions authorizing “gay marriage” and abortion on demand.

The Clements film, [“Let My People Go.”](#) was shown at the Frederick County Conservative Club event and provided much of the evidence of a stolen election and the need for honest judicial review. The event concluded with members of the audience singing the Star-Spangled Banner in concert with J6 prisoners. Clements, who maintains a YouTube channel at the present time, [The Professor’s Record](#), continues to examine the evidence and the plight of the J6 defendants.

As I wrote at the time, videos of the “insurrection” indicated that many protesters were invited and escorted into the Capitol. Babbitt, a 35-year-old California woman, a 14-year veteran of the Air Force and Trump supporter, was then surrounded and killed.

Attorney Terrell N. Roberts, III, who had represented Ashli’s husband and family members, [noted](#) that “... the officer who shot Ashli never attempted to arrest her. Nor did he call on his fellow officers to arrest her. Instead, he fired a shot into her chest. Witnesses confirm that the officer did not give Ashli a single verbal warning prior to firing. In fact, Ashli was not even aware that the officer was present, as he was located in the doorway of a room off to the side of her field of vision.”

The evidence clearly shows that the Capitol Police shooter, Lt. Michael Byrd, did not reasonably believe he was in danger and police officers near where Babbitt was shot did not think she was a threat because otherwise they would have arrested her. Nevertheless, the Biden “Department of Justice” said it would not pursue criminal charges against Byrd. He was not disciplined in any way.

“Justice for Ashli Babbitt” pages are on the X and Facebook social media platforms. A place called “Freedom Corner” near Washington D.C.’s city jail is the scene of vigils to remember the protesters.

The family of Ashli Babbitt has filed a [wrongful death lawsuit](#) against the U.S. government over her murder. It notes that Lt. Byrd “later confessed that he shot Ashli before seeing her hands or assessing her intentions or even identifying her as female. Ashli was unarmed. Her hands were up in the air, empty, and in plain view of Lt. Byrd and other officers in the lobby. Ashli posed no threat to the safety of anyone.”

Faced with such government corruption, comparable to Russian treatment of dissidents, the Clements film appeals for Divine intervention to save America.

Robyn Sachs of the [Maryland Voter Integrity Group](#) called the Clements “Let My People Go” film “a modern-day deliverance story where the American people are the slaves persecuted for exercising their freedoms and controlled by the warlords of a rigged election.”

A Congressional candidate in Maryland’s sixth district and long-time Trump supporter Dan Cox also appeared on stage, declaring the 2020 presidential election stolen and urging residents to vote for him in the May 14 Republican primary because he is the only candidate willing to say the truth.

The Frederick County Conservative Club, led by Fred Propheter, has been encouraging local conservatives to get involved in the fight for election integrity and sign up as election judges.

The American public remains negative about the state of the nation's economy and nearly 70% of Republicans do not believe Joe Biden's 2020 election win was legitimate, according to a CNN poll conducted by SSRS. August 3, 2023.

Attacked for “conspiracy theories” and being an “election denier” by the media, Clements documents how the fraud occurred through such means as the manipulation of electronic and computer voting systems and why a return to paper ballots is the only viable solution.

Indeed, millions of Americans witnessed the dramatic development of what the film calls “Biden injections” of votes on election night and in the early morning, as a Trump lead evaporated in several critical states and Biden was declared the winner after mysterious pauses in the vote count.

Among other sources and experts, Clements cites evidence from the “2000 Mules” film, which used cell phone geolocation data and video surveillance of mail-in ballot drop boxes to document the case for voter fraud. Catherine Engelbrecht, founder of True the Vote, was a researcher for the film and argued that mail-in ballots were (and are) part of a well-crafted strategy to subvert election integrity through forced reliance on unstable, untested, insecure processes.

At the time, this writer had done a YouTube interview with a Republican attorney who had photographic evidence of an alleged vote fraud operation in Detroit, Michigan, in which cardboard pizza boxes were placed on the windows of a vote counting center so legally qualified challengers could not see into the room. Challengers were supposed to have the right to see votes counted and to challenge ballots. In addition, in the Detroit case, menacing “security guards” were used to discourage oversight. (see page 12).

That interview – and more than 500 pro-American videos – were then censored by YouTube.

One of the taboo topics even today is the evidence that the move toward electronic ballots and mail-in voting and away from paper ballots and an auditable paper trail is a dangerous trend that has been exploited by the Democratic Party. It could happen again in 2024.

We should remember that Richard Nixon had won the 1960 election against John F. Kennedy but had that election stolen from him. He was persuaded to avoid contesting the election in the name of national stability. Subsequently, he was elected president in 1968 and re-elected in 1972.

Even before 2020, we had hard evidence – confirmed by the Washington Post – that Democrats do steal elections and do not want Republicans to uncover their techniques for doing so.

In a story about Michael Roman, one of Trump’s co-defendants in the case being prosecuted by dirty DA Fani Willis in Georgia, the Post said that he got a break in politics in 1993 knocking on doors for Philadelphia lawyer Bruce S. Marks, a friend of Roman’s for more than 30 years who was running a Republican campaign for the Pennsylvania State Senate.

“Marks appeared to lose in a close race,” the paper said, “but overturned the result in federal court by proving that his Democratic opponent benefited from fraudulent absentee ballots. The case caused Roman to fixate on voter fraud years before it became central to Republican politics.”

In fact, Marks and Roman wrote a 2020 [article](#), “Some advice from victims of voter fraud who won the day,” explaining the 1993 case in these terms: “After months of legal battle, a federal judge issued a landmark decision finding that candidate William Stinson and the Philadelphia city officials engaged in massive fraud involving thousands of

illegal votes, removed the Democrat from office, and instated the rightly elected Republican as senator. A dozen campaign workers were convicted of election fraud.”

In conjunction with the fraudulent elections, the federal or Deep State modus operandi is to harass and crush conservatives and Christians through a secretive intelligence operation involving FBI operatives and agents that targets and uses lethal force against them.

In a strange twist, one of the victims of January 6 turned out to be a pro-family activist who wasn't even at the event. That activist, [Arthur Schaper](#) of Mass Resistance, had booked a ticket to D.C. for the protest but didn't go. He told the FBI agents he wouldn't answer any more questions without a lawyer.

Schaper was a guest on my America's Survival TV show (which was censored by YouTube) and described the strange encounter. It is still not known how the FBI became aware he had a plane ticket to D.C., where he lived, and how they got into his apartment complex. But the incident suggested the FBI has mainstream conservative groups under surveillance.

How the FBI Protected a Pervert

Several courageous female athletes in Senate testimony provided direct evidence of how the FBI covered-up the crimes of the sexual pervert Larry Nassar and they sued the Department of Justice over the FBI's conduct. Nassar, a doctor at Michigan State University, was employed as the USA Gymnastics National Medical Coordinator and a "treating physician" for America's top gymnasts. He pleaded guilty to seven counts of first-degree criminal sexual conduct, as well as Receipt and Attempted Receipt of Child Pornography, Possession of Child Pornography, and other crimes. He was sentenced to 60 years in federal prison. The Department of Justice on April 23, 2024, announced a settlement of \$138.7 million to be distributed to the victims, acknowledging claims "that the FBI failed to conduct an adequate investigation of Nassar's conduct."

In this context, it must be noted that Mark Houck, a Catholic father of seven children, was arrested at gunpoint by dozens of FBI agents in front of his weeping children for allegedly violating a federal law restricting pro-life protests. (He was acquitted). The FBI was even caught with a memo authorizing surveillance of traditional Catholics. Meanwhile, pro-lifers are being [incarcerated](#) for their efforts to save innocent children from being exterminated at the hands of abortionists, while [reports](#) continue to circulate about the alleged illegal trafficking of aborted baby body parts by Planned Parenthood.

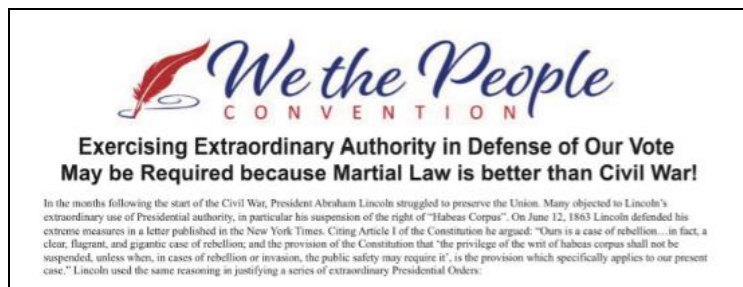
My Pillow's Mike Lindell appears briefly in the Clements film, but not to make his sensational claims of foreign-directed cyber warfare attacks on electronic voting machines. His film "[Absolute Proof](#)," described as "Exposing Election Fraud and the Theft of America," cites a controversial "whistleblower" Dennis Montgomery, an alleged former NSA/CIA contractor, as a source for claims that computer screens of data (packet captures) are intercepts of the cyber-attacks.

Geopolitical analyst Jeff Nyquist had told me at the time, “I do not think it is likely that thousands of voting machines were hacked by China, or that the whole thing was managed from overseas.” Instead, he said he thinks “corrupt party machines” in key places like Detroit and Philadelphia conducted the vote fraud “for their own reasons,” primarily getting Biden and other Democrats elected. I interviewed Ed Welsch of Chronicles magazine, who described how the Lindell "Cyber Symposium" backfired and failed to provide “absolute proof” of foreign-directed cyber-attacks on the election.

This is not to say that cyber-attacks did not happen. A high-level [report](#) for the federal government by two computer experts, J. Alex Halderman of the University of Michigan, and Drew Springall of Auburn University, was eventually released in June 2022, documenting that Dominion voting machines were susceptible to hacking. The Biden Administration had tried to keep it secret.

In a December 20, 2020, column, I had quoted military whistleblower Lt. Col. (Ret.) Tony Shaffer, who had appeared on one of my television shows, as saying that President Trump should never concede an election “victory” to Biden because there was just too much hard evidence -- of the kind presented in the Clements film -- that the election was stolen.

At the time, we [argued](#) that Trump should have exercised his constitutional authority to stay in office until a fair and honest election was held.



Indeed, on December 1, 2020, as the fate of the Trump presidency hung in the

balance, Tom Zawistowski, President of the TEA Party affiliated We the People Convention (WTPC), published a full-page ad in the Washington Times newspaper demanding that President Trump invoke limited martial law in order to allow the U.S. military to oversee a new free and fair federal election if legislators, courts and the Congress did not follow the Constitution.

My interview with Tom Zawistowski was one of those videos censored by YouTube.

The ad published by Tom Zawistowski discussed the executive actions implemented by President Abraham Lincoln in his efforts to save the Union during the Civil War and the need for similar actions in the matter of the “literal civil war” threatening the Trump presidency and “dividing our nation today.”

“Then, as now,” said the ad, “a President with courage and determination was needed to preserve the Union. Today, the current threat to our United States by the international and domestic socialist/communist left is much more serious

than anything Lincoln or our nation has faced in its history - including the Civil War.”

The new Civil War began under President Barack Hussein Obama, who promoted the homosexual agenda by celebrating the 1969 homosexual riots at a seedy Mafia-run bar known as the Stonewall Inn in New York City. Several police officers trying to enforce the law at the sleazy establishment were injured by violent homosexuals. Obama, whose childhood mentor, Frank Marshall Davis, was a bi-sexual drug-using communist, said that “...the riots at Stonewall gave way to protests, and protests gave way to a movement, and the movement gave way to a transformation that continues to this day.”



These so-called “Pride” protests became a template for the George Floyd riots and the current anti-Israel and anti-Semitic campus disturbances. This is the continuation of Obama’s “Permanent Revolution.”

As we know, Trump avoided being another Lincoln, leaving the door open for Joe Biden and his Obama-era personnel to take control of the White House. Under the control of people Trump rightly labels as Marxists, the feeble Biden has become the anti-Lincoln, using extraordinary measures to destroy the Union and exacerbate a Civil War.

Interestingly, the Clements film features Lincoln as an historical figure whose Emancipation Proclamation was necessary to secure America’s future as a free nation. In the discussion period after the film, Clements noted that this executive action was followed by a Day of National Humiliation, Fasting, and Prayer that included repentance.

He told a personal story about a pastor who escaped Romania under communism and said the system came crashing down when there was an awakening that they had to act against the corrupt system.

Clements, who now travels around the country warning people about the Marxist menace in America, also noted that [Pastor Richard Wurbrand](#) had suffered in a Romanian prison at the hands of the communists, eventually founding the group Voice of the Martyrs. He also wrote a book on the Satanic influence behind Karl Marx, the father of communism.



Matt Drudge of the Drudge Report would not accept these two ads for placement on his website, saying through a spokesman they were "too controversial." At this point in time, Clements says, the fight must also be waged at the local level, as patriots should confront officials about election integrity by arguing for paper ballots.

Grass-roots action is happening in Maryland, as citizen volunteers led by Kate Sullivan and David Morsberger wrote a detailed [report](#) finding 79,000 inaccuracies and ineligible voter records in the state's voter rolls. A report released by the Office of Legislative Audits of the State General Assembly [confirmed](#) a failure by the State Board of Elections "to identify and purge the deceased from voter rolls as well as a time lag in reporting people who allegedly voted more than once," one [report](#) noted. The group [United Sovereign Americans](#) has highlighted through a [lawsuit](#) and news releases documentation about election irregularities, improper certification of voting machines and noncompliance with the Public Information Act (PIA) by the authorities.

Locally, activists find their voice through the Jen Charlton show, carried on radio station WFMD. She, too, appeared at the screening of the Clements film.

The Democratic Party-controlled state government responded with a bill to outlaw dissemination of “misinformation” that could cause personal embarrassment to members of the State Board of Elections. “They’re coming for our free speech,” declared Robyn Sachs.

The problem we face today is corruption in government, the media, and the church that runs so deep that it is uncomfortable for some to even talk about it publicly.

The Christian existentialist philosopher, Soren Kierkegaard, wrote about the corruption in the Danish State Church, declaring that everyone knew privately that the system was rotten and corrupt but they would not say so publicly. “Just as one says that death has marked a man, so we recognize the symptoms which demand to be attacked. It is a battle against lies,” he said.
