Dear Director Patel:

I write with urgency about the communist and Palestinian groups gathering in Washington, D.C., on April 5. My column on this matter, *FBI Must Probe the Communist-Muslim Alliance*, was distributed by my organization, America's Survival, Inc. (ASI), and is available at [www.usasurvival.org](http://www.usasurvival.org).

I note the significance of the Tesla firebombing case in Las Vegas that reveals links between the perpetrator, Paul Hyon Kim, and communist groups, including the Communist Party USA, and Palestinian causes.

**There are federal statutes that can be used against members of these groups and their patrons, such as Neville Roy Singham and George Soros, and state Attorneys General can identify and register local and state communist groups as foreign agents linked to Iran, Russia, China, or all three.**

We discovered that the communist groups sponsoring April 5 are using tax-exempt funds to organize subversion of the United States.

We ask for the opportunity to discuss our research with you and your staff.

**During the eight years of the Obama Administration and four years of Joe Biden, it appears the FBI did not investigate the nexus between communist and Palestinian networks. Under Trump's first term, as you documented in your excellent book *Government Gangsters*, the FBI was consumed with investigating Trump and his aides.**

There was an indictment in 2023 of members of the African People's Socialist Party (APSP) by the Department of Justice for operating as agents of a foreign power – Russia. According to the indictment, the funding was concealed through multiple bank

accounts and accounting mechanisms, and the participants in the “conspiracy” tried to hide their own involvement. But three leaders of the APSP were convicted on the relatively weak charge of merely “conspiring” to act as agents of the Russian government.

There are far more serious cases of foreign agents operating in the United States, and the Trump Administration is beginning to address this problem through use of the 1952 Immigration and Nationality Act (INA) to arrest Mahmoud Khalil, a former Columbia University graduate student born in Syria who is not an American citizen but resides on American soil, for “activities aligned to Hamas,” a designated terrorist organization.”

The “Annual Threat Assessment of the U.S Intelligence Community,” released by the Trump Administration, adds an important reference to al-Qaeda, the group responsible for killing nearly 3,000 people on American soil on 9/11, saying, “Its leaders, some of whom remain in Iran, have tried to exploit anti-Israeli sentiment over the war in Gaza to unite Muslims and encourage attacks against Israel and the United States.”

The terror group’s “media apparatus” has “issued statements from leaders and the group’s affiliates supporting HAMAS and encouraging attacks against Israeli and U.S. targets.”

To understand the current demonstrations on behalf of Hamas that have turned anti-Semitic and violent, the FBI website is a source of important information about the Holy Land Foundation case that dates to 1994 and resulted in convictions in 2008. The FBI defined the goal of Hamas as “creating an Islamic Palestinian state by eliminating the State of Israel through violent jihad” and added that, even after the September 11, 2001 terrorist attacks against the World Trade Center and Pentagon, Hamas’ public statements urged “support for continued violence against Israel and the United States.”

In this case, the Council on American-Islamic Relations (CAIR) was identified as a member of the Palestine Committee of the Muslim Brotherhood, which gave rise to terrorist organizations such as Hamas. It was officially designated as a Foreign Terrorist Organization back in 1995 but continues to be a source of inspiration for many of the organizations backing April 5.

CAIR, which describes itself as the nation’s largest Muslim civil rights and advocacy organization, has urged its “community members” to join the March on Washington for Palestine to be held on April 5th at 1 p.m. in Washington, D.C.

**I covered a previous March 18, 2023, Communist rally in Washington, D.C. that included the Workers World Party, Communist Party USA, the Democratic Socialists of America, African People’s Socialist Party, Freedom Road Socialist Organization, Socialist Unity Party, Spartacist League, Revolutionary Communist Party, and the Party of Communists USA.**

These groups are involved in the April 5 event.

I was in New York for the November 13, 2010, memorial service for the dead terrorist (and 1983 Capitol bomber) Marilyn Buck, released by the Obama Administration from prison. I learned important information about U.S. links to fugitives from justice. It was there that Buck's attorney, Harvard's Sofiyah Elijah, introduced an audio recording of Black Liberation Army (BLA) cop-killer Joanne Chesimard, now living in Cuba, talking about how her "sister" had obtained her freedom.

**After attending this event I met with FBI agents to discuss my findings. I figured the information I had could help the FBI locate Chesimard, a fugitive. She remains in Cuba.**

I also attended a 2014 Washington, D.C., "Five Days for the Cuban Five" event in honor of Cuban spies, where former Weather Underground terrorist Linda Evans (pardoned by President Clinton) spoke under the watchful eyes of José Ramón Cabañas, Chief of the Cuban Interests Section in Washington, D.C. Evans and Rafael Cancel Miranda emphasized the opportunity to get their comrades released from prison -- most notably Oscar Lopez Rivera, a member of the Cuban-supported Puerto Rican FALN that claimed responsibility for over 140 bombings, including the infamous January 24, 1975, lunchtime attack on Fraunces Tavern in New York City which killed four innocent people.

His sentence was commuted by President Obama while Linda Evans became a "Soros Justice Fellow." Her assignment was to "increase civic participation of former prisoners, launch a public education campaign highlighting the social, political, and economic obstacles faced by former prisoners and engage in policy advocacy on behalf of them."

In connection with the April 5 "March for Palestine," I provided a first-hand eyewitness report on the previous communist-organized "Free Palestine" rally in Washington, D.C. on November 4, 2023, that included photos.

This year, on March 8, I covered an anti-Trump "resistance" rally in the Washington, D.C. area, taking photographs of people threatening violence, including assassinations of President Trump and Elon Musk, and featuring Palestinian flags.

**Alarmed by the direct calls for violence, I called the local FBI office about these threats and was directed to the Baltimore, Maryland FBI office and no one picked up the phone. I called the local Sheriff's office and a deputy said they could not act on the threats unless there was evidence of an actual conspiracy to kill Trump or Musk.**

Over the course of my career, I have covered literally dozens of demonstrations on the left, from anti-nuclear protests featuring Jane Fonda to openly communist conferences sponsored by the Workers World Party (from which I was ejected), and have never witnessed such a hunger for death and destruction, except for the Weather Underground terrorism of the 1960s and 70s.

This violence-prone movement has been developing for decades.

Because of the mounting evidence of U.S.-based support for foreign terrorist groups, it was reported that members of the FBI Joint Terrorism Task Force on September 24, 2010, raided the home and office of Michael Kelly, a member of the Freedom Road Socialist Organization (FRSO), an openly communist group, in the U.S. The Freedom Road Socialist Organization describes itself as a revolutionary socialist and Marxist-Leninist organization in the United States.

The FBI raids were designed, according to legal documents in the case, to find connections to the Revolutionary Armed Forces of Colombia (FARC), the Popular Front for the Liberation of Palestine (PFLP) and the Lebanese Islamic terrorist group Hezbollah. FBI agents specifically declared they were looking for evidence of illegal FRSO support to foreign terrorist organizations.

It appears that the investigation into the Freedom Road Socialist Organization was then dropped. Medea Benjamin, founder of Code Pink, publicly pressed Obama Attorney General Eric Holder to intervene with the FBI to stop the probes. During his stint in the Clinton Administration, Holder was directly involved in the Clinton pardons of Weather Underground members Linda Evans and Susan Rosenberg.

It appeared that the FBI investigations could, if carried to their logical conclusion, uncover links by some of the protesters and the activists under investigation to President Obama himself.

This case should be re-opened.

**Weather Underground terrorists Bill Ayers and Bernardine Dohrn, who backed Obama for president, were linked to these networks. They participated in protests in Egypt in January 2010 on behalf of the “Gaza Freedom March,” to deliver “humanitarian aid” to Hamas-run Gaza. Israel conducted a raid in May 2010 on a flotilla delivering aid to Gaza.**

Ayers and Dohrn themselves traveled to communist-controlled Venezuela to show “solidarity” with anti-American governments and movements. They even showed up in Germany on a panel with former members of the Red Army Faction, a violent terrorist group that killed U.S. military personnel and bombed U.S. military bases during the 1970s.

I recorded a video showing Benjamin and Dohrn in deep and friendly conversation during a left-wing conference before Dohrn exploded over allegations that she was involved in the bombing murder of a policeman. In that case, Dohrn was implicated in the murder of Police Sgt. Brian V. McDonnell in San Francisco back in 1970 but escaped justice for her crimes because liberal prosecutors didn't want to charge her with murder.

**My group America's Survival brought this case to the public's attention, including at news conferences at the National Press Club in Washington, D.C. and in San Francisco, as part of our “Justice for Victims of Weather Underground Terrorism”**

**project. We continue to urge federal authorities to get to the bottom of what really happened on February 16, 1970, when a bomb filled with heavy metal staples exploded and ripped through the body of San Francisco Police Sergeant Brian V. McDonnell at the Park Station police headquarters. McDonnell was in the hospital for two days, bleeding from his wounds, before he finally died.**

Declassified intelligence documents show that Weather Underground member Kathy Boudin traveled to the old Soviet Union. Her father, Leonard Boudin, was a member of the Communist Party and registered Cuban agent. Other members of the group underwent guerrilla warfare training in Cuba.

Cuban Communist DGI official Julian Rizo gave a speech to the Weather Underground terrorists, telling them, “You come from a society that must be destroyed. It’s your job to destroy that society.”

In another significant case, it took years for Rasmieh Yousef Odeh to be deported from the United States after concealing her conviction in Israel for participating in a terrorist bombing. She was a member of the Popular Front for the Liberation of Palestine (PFLP), which has been designated a terrorist organization by the United States. She had obtained a United States immigrant visa in 1994 and had lived in the United States for 22 years. In 2004, she obtained United States citizenship. She was ordered deported in 2017.

The last congressional panel to investigate these networks was the House Internal Security Committee, the successor to the House Committee on Un-American Activities. It published a 1974 study linking the communist Workers World Party (WWP) and its front organizations to Cuba, Arab terrorists, and prison agitation. This committee was abolished by congressional liberals in 1975.

**The WWP is still in existence but has been superseded by the Party for Socialism and Liberation and its front, the ANSWER Coalition, the groups behind April 5.**

My organization, America’s Survival, Inc. (ASI), an educational non-profit, is currently working to re-establish Congressional committees or subcommittees to investigate internal security issues.

For many years, there was a comparable body in the Senate, which went by different names but tackled such matters as “Castro’s Network in the United States,” a 1963 investigation into the “Fair Play for Cuba Committee” that we later learned included JFK assassin Lee Harvey Oswald.

Donald I. Sweany, Jr., a research analyst for the House Committee on Un-American Activities and its successor, the House Committee on Internal Security, saw the need for such a committee and issued a statement in 2012 about “the dangerous and sovereignty-threatening subversive activities currently plaguing America,” adding:

**“This subversion emulates from a host of old and new entities of Marxist/Communist revolutionary organizations and allied militant and radical groups, some of which have foreign connections.”**

Presently, however, the American people are depending on the FBI to uncover what is happening. That is why I am writing you.

For starters, I recommend the 1968 congressional report, “Guerrilla Warfare Advocates in the United States,” to understand the waves of violence we are witnessing and the sources of the violence. That report quoted Jesse Gray, the former Harlem organizer for the Communist Party USA, as calling for guerrilla warfare against the United States. It documents how the forerunner of the Weather Underground, the campus-based Students for a Democratic Society (SDS), gave “open support” to guerrilla warfare in the United States and quoted one SDS leader, Tom Hayden, as endorsing “urban guerrillas” or “mass armed resistance” as “the only realistic alternative” to “electoral politics.”

Also relevant is the Huston Report, compiled by former Nixon aide Tom Huston during a comparable time of campus unrest leading to violence and terrorism. It documented how Weather Underground operatives received training and had contacts with foreign and communist countries. It is a detailed examination of foreign communist support of “revolutionary” protest movements in the United States during the 1960s and 1970s.

Regarding the violent attacks on Tesla cars and dealers, it has been reported that the FBI has launched a unit with the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) to examine the network behind this. This is great news.

**To understand the global context, when the Soviet Union collapsed and was replaced by Russia on the global stage, billionaire hedge fund operator George Soros picked up the financial slack in the Western countries, financing many of the same old communist and Marxist groups that had done the dirty work of the old Soviet Union. For example, Soros financed Critical Resistance, a group founded by Communist Party USA member Angela Davis and dedicated to abolishing prisons. Davis ran as the vice-presidential candidate on the Communist Party USA ticket when the party was funded and controlled by Moscow.**

This is significant. A one-time puppet of Moscow, Davis became an advocate of Cultural Marxism, having learned communist tactics under Frankfurt School Professor Herbert Marcuse, who made Brandeis University into what critics called a “School for Terrorists.” The school produced female terrorists for the Weather Underground and the Islamic Jihad.

Davis was so dedicated to the communist philosophy that ruled the Soviet Union and its client states that she traveled to East Germany during the time of the Berlin Wall and had a friendly meeting with East German communist dictator Eric Honecker. Her receipt of the Lenin Peace Prize in Moscow was recorded in an Associated Press video that is

now posted on YouTube. You can see Davis hug a Soviet official and pay tribute to the Soviet revolution, with a bust of Lenin in the background.

It was Soros who put more than \$32 billion into a “progressive” network of groups that gave us the presidency of Barack Hussein Obama and then Joe Biden, after they undermined President Trump’s first term through the Russia-gate hoax financed by Hillary Clinton and pursued by the FBI.

To understand one important aspect of what Soros is doing, please note that Soros had hired Aryeh Neier as president of one of his affiliates, the Open Society Institute (OSI), in 1993. Neier had worked for the ACLU for 15 years, including eight as national director. In his book, *Taking Liberties: Four Decades in the Struggle for Rights*, Neier talked about his role in creating the Students for a Democratic Society (SDS), the same group that would eventually spawn the terrorist Weather Underground.

Retired New York City Police Sgt. Jim Wilson says that Neier, as head of the New York Civil Liberties Union, played a role in the destruction of the New York City police intelligence files on communists and subversives.

One of Neier’s close associates at the ACLU was identified Communist Party USA member Frank J. Donner. The 1959 report of the House Committee on Un-American Activities, “Communist Legal Subversion: The Role of the Communist Lawyer,” features Donner as one of several lawyers identified as members of the Communist Party USA (CPUSA) before the committee.

Donner thanks Aryeh Neier for help in writing his book *The Age of Surveillance*. Neier endorsed the book.

**Based on history, as documented in the report, “Guerrilla Warfare Advocates in the United States,” we can predict that advocacy of violence leads to actual violence, even terrorism and guerrilla warfare.**

This escalated in the 1970s to the point where communist terrorist groups such as the Weather Underground were bombing police stations and killing police officers. I personally obtained and posted the declassified summary of intelligence information concerning the foreign connections of the Weather Underground, whose leaders escaped justice and went on to support Barack Hussein Obama for the presidency in 2008. The group received terrorist training in Communist Cuba and was advised by Soviet and Cuban intelligence agents.

Based on my research, I conclude that America is and has been under attack by foreign ideologies based in Russia and China while anti-American cultural tendencies, also known as Cultural Marxism, are encouraged by the national Democratic Party. Ideologically, transgenderism can emerge as a leading motivation for violence and terrorism, as we can see in the case in Loveland, Colorado, in which a transgender by the name of Lucy Grace Nelson, also known as Justin Thomas Nelson, was arrested for

a series of attacks on a Tesla dealership. Investigators found a container of gasoline plus a box of bottles and wick material inside Nelson's car.

To understand why this is happening, consider that Leslie Feinberg, founder of the modern transgender movement, was a member of the communist Workers World Party, and his/her books included *Rainbow Solidarity in Defense of Cuba*. He/she represents the "Cultural Marxism" that has infected the lives of many young people. These confused people constitute many of the foot soldiers in the anti-Trump "resistance."

If there are any doubts that these networks are capable of violence and terrorism, I would only remind you that during Trump's first term, the May 2020 George Floyd communist-inspired BLM riots in Lafayette Park included looters smashing windows, setting fires, attacking police, and almost burning down historic St. John's Church near the White House.

Before the George Floyd riots of May 2020, dubbed a "black rebellion" by communists, we faced the Harlem riots of 1964, the Watts riots of 1965, and the 1968 riots in America over the assassination of Martin Luther King, Jr.

Then-Communist Chinese dictator Mao Zedong issued a statement "in Support of the Afro-American Struggle Against Violent Repression." That support continues through Neville Roy Singham, identified as a U.S. citizen with ties to the Chinese Communist Party (CCP). Communist and Palestinian organizations reportedly linked to him include:

There are other examples of the escalation of -- and preparation for -- violence.

Exploiting the acquittal of former Marine Daniel Penny, who defended fellow subway passengers in New York City against a drug-crazed lunatic, the Marxists in Black Lives Matter (BLM) immediately began threatening violence and denouncing America, with one saying, "We need some black vigilantes. ... People wanna jump up and choke us and kill us for being loud? How about we do the same?"

In another example of the rising threat of violence, the motivation of the well-educated fanatic who killed the UnitedHealthcare CEO on the streets of New York City is clear.

Luigi Mangione graduated from the University of Pennsylvania and is another Ivy League terrorist, cut from the same cloth that decades ago produced such Weather Underground terrorists as Mark Rudd of Columbia University.

People like Luigi Mangione are the inevitable result of anti-corporate brainwashing through *Marxist Madrassas*, the name of our 2016 book on how "well-educated" people turn out as communists. They claim to be saving the planet from evil corporations and the system of capitalism.

The Marxist-oriented People's Action Institute, which ran a campaign of harassment against UnitedHealthcare and its executives, receives support from such socialists and extremists as Reps. Ilhan Omar, Alexandria Ocasio-Cortez, and Rashida Tlaib. It traces its history to Heather Tobis, who later married Paul Booth, a founder of Students for a Democratic Society, the same communist group with ties to Cuba and the Soviet Union that organized violence and terrorism in the 1960s and 70s.

The People's Action Institute also claims to have worked to "turn back the tide of the Reagan Revolution" in the 1980s.

**The political left has greeted Luigi Mangione as a hero, proving that the hatred of capitalism and the private sector displayed by the terrorist known as Unabomber is still on full display.**

The Unabomber was Ted Kaczynski, educated by Harvard before he became a Luddite hiding out in the woods who staged an 18-year bombing campaign that killed three people and injured many more before his capture by the FBI in 1996. In this case, the FBI was tipped off to his location by his brother. A psychiatric report said his mental state had deteriorated to the point where he had "fantasies of being a female" and "became convinced that he should undergo sex change surgery."

Another prominent advocate of “transgender liberation” is Bradley/Chelsea Manning, the former U.S. Army analyst sentenced to prison for espionage for his/her collaboration in the release by WikiLeaks of thousands of top-secret intelligence reports. Former President Obama commuted Manning's sentence, which was originally 35 years in prison for espionage, after only seven years in prison. Manning was an open homosexual in the Army before deciding to become a woman.

On Capitol Hill, we saw the spectacle of the reappearance of Bradley Manning demanding access to women’s bathrooms.

The incident occurred when Rep. Nancy Mace demanded that the first transgender member of Congress, Rep. “Sarah” McBride, not be allowed to use women’s restrooms on Capitol Hill.

Consider the case of the transgender killer, 28-year-old “Audrey Hale,” who opened fire at a Christian school in Tennessee and killed six people, and whose “manifesto” was illegally concealed by the FBI.

The homosexual movement, as we have documented, was founded by a member of the Communist Party by the name of Harry Hay who wore a dress and advocated pedophile rights. We released his FBI file, compiled during the days of Director J. Edgar Hoover, who investigated extremists of all kinds.

Just 10 days before Christmas, Abundant Life Christian School was targeted, this one in Madison, Wisconsin, and two people were killed. Initial reports indicated the killer was a teenage girl who considered herself a feminist and was confused about her own place in the world, in rebellion against her own parents. She may have been transgender.

The anti-Christian terrorism is not unique. The U.S. Conference of Catholic Bishops has identified at least 372 incidents of arson, vandalism, and other destruction at Catholic Churches in the United States across 43 states and the District of Columbia since May 2020.

As indicated, a major source of funds for the anti-Trump resistance is the billionaire hedge fund operator George Soros, a Hungarian-American who has spent tens of billions of dollars to create and sustain a “progressive” movement that put Barack Hussein Obama in the White House, followed by Joe Biden.

He got entry into the United States and acquired American citizenship through false pretenses. He claimed to be pro-American when he was influenced by a former Marxist, Karl Popper, and played a role in a Nazi campaign in his native Hungary to loot Jews trying to escape the Holocaust. As an adult, he defended his actions.

After getting entry to the United States, he declared the “capitalist threat” as his major enemy, effectively throwing his weight behind the global campaign to destabilize the West, especially the United States.

Soros has funded groups promoting illegal immigration and individuals supporting Islamic terrorism, such as the far-left lawyer Lynne Stewart, convicted of aiding the terrorists who staged the first bombing attack on the World Trade Center in New York. He is also a major funder of the ACLU, now specializing in lawfare against the Trump Administration.

Soros is now turning his fortune over to his son Alexander, who is marrying Huma Abedin, a former top aide to Hillary Rodham Clinton.

We held a “Vetting Obama” Conference on July 19, 2012, that included an analysis of her ties to the Muslim Brotherhood and the question of how she obtained a top-secret security clearance to serve as Deputy Chief of Staff in the State Department under Obama. We wanted to know if Abedin’s Muslim Brotherhood connections were disclosed and/or examined when she gained access to national security information.

Huma Abedin was previously married to Anthony Weiner, a former member of Congress sentenced to 21 months in prison for transferring obscene material to a minor. After marrying Alexander Soros, Huma Abedin will be a major partner in a “power couple” relationship that will inevitably target the Trump Administration for complete destruction.

The government of India has conducted raids on the Soros network in that nation. The raids were undertaken by the Directorate General of Economic Enforcement or Enforcement Directorate (ED), an Indian government agency that enforces economic laws and fights economic crimes in India. The investigation is said to be focused on the misuse of foreign funds by the Soros network.

In the United States, the FBI, in cooperation with the Drug Enforcement Administration, could examine Soros’s financial operations based offshore that are considered conducive to money-laundering.
