

Marked for Death

Joe Biden says the world community does not want Trump in the White House. In an interview, he said he had attended many meetings over the last three and a half years and inevitably a “world leader” would pull him aside and say, “He can’t win. You can’t let him win.” The Financial Times, the trusted voice for globalists, [declares](#) Trump a “grave threat.”

Meanwhile, the Biden-Harris campaign is denouncing Trump as a threat to democracy and would-be-dictator who will prosecute them for their crimes. They are desperate. But their desperation is designed to motivate anti-Trump zealots and fanatics. It is a charge that will energize would-be assassins, such as those discussed in this report.

By portraying Trump as a Hitler-like threat to democracy, they are creating an atmosphere in which assassination plots can be carried out for the benefit of the Deep State and another Trump enemy, the United Nations, under the control of China, Russia, and Iran.

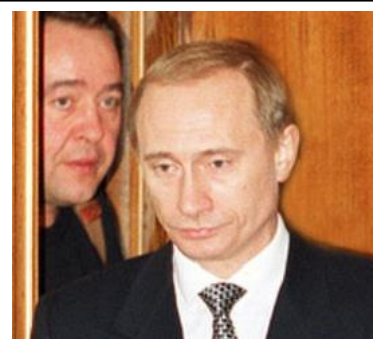
Presidential candidate Robert F. Kennedy, Jr., has been denied Secret Service protection. Trump has it, but that is no guarantee that he will be safe. The Secret Service guarded Trump’s documents at Mar-a-Lago but roughly 30 FBI armed agents arrived on the scene anyway. In this case, the FBI and Secret Service [coordinated](#) their efforts.

The FBI raid on President Trump’s home included an authorization for lethal force and provisions for a medic to care for the wounded or dying.

It was a show of force, letting Trump know who is really in charge. Even the Secret Service can’t or won’t protect Trump from the FBI. This is why Trump needs private security guards, preferably ex-military professionals certified as pro-Trump.

It is sad to say, but America has a “Murder Inc.” located in Washington, D.C. in the federal centers of government that has been accumulating weapons and power for decades.

Consider the case of Clinton White House lawyer Vincent Foster, whose dead body was dumped in a public park after he obtained [documents](#) regarding NSA surveillance procedures and practice and had knowledge of various Clinton scandals, including

details about the federal assault on the religious compound in Waco. To this day, official agencies want the public to believe it was a suicide.

However, investigative work by attorney John H. Clarke, grand jury witness Patrick Knowlton, researcher Hugh Turley, and AIM founder Reed Irvine demonstrated that it was a murder disguised as suicide, a technique developed by the KGB and described in detail by former KGB officer Peter S. Deriabin in testimony released by the Senate Internal Security Subcommittee in 1965 under the [title](#), *Murder International, Inc.*

Knowlton was harassed and pressured by federal agents to change his story to conform to the narrative that Foster drove himself to Fort Marcy Park, where the body was found, and killed himself.

Pavel Sudoplatov, deputy director of foreign intelligence of the NKVD (later called KGB), reveals in his book, *Special Tasks*, the existence of a poison laboratory, called “Lab X” as far back as 1937. The lab developed poisons used to assassinate enemies of Moscow at home and aboard. Former KGB Colonel Vladimir Putin, the Russian president, continues this practice, ruling through murder and killing his political opponents, usually with KGB poisons such as Ricin and Novichok.

Russian defector Sergei Skripal and his daughter were poisoned in 2018 in England.

Alexander Litvinenko, a former KGB officer who had identified Dr. Ayman al-Zawahiri of al Qaeda, as a Soviet KGB agent, was poisoned to death in London, where he had fled, after he wrote a book, [Blowing up Russia](#), on how Russian agents are behind acts of alleged Islamic terrorism. (ASI published a [special report](#) on the hidden hand of the KGB in global terrorism.)

Although the FBI and local police [called](#) it a case of a drunk man falling down, it was [suspected](#) that the death of former Putin aide Mikhail Lesin demonstrates that the Russians can strike deep in the heart of Washington, D.C.

Lesin, Russian creator of the propaganda channel Russia Today (RT), was found dead in a Washington D.C. hotel room in 2015 after experiencing “blunt force trauma,” with some federal agents saying anonymously that it was clearly caused by a hard foreign object, such as a baseball bat. Lesin was [accused](#) of violating U.S. anti-money-laundering laws when he purchased expensive California real estate and was apparently planning to cooperate with U.S. authorities investigating Russian espionage operations to get those charges dropped. The FBI was aware of this.

However, another suspicious American “suicide” was that of Jeffrey Epstein, the politically-connected mastermind of a pedophile network serving the rich and

powerful that involved gay blackmail. The story they want you to believe is that the police in a prison facility who were guarding him were either asleep or playing computer games when Epstein hung himself using sheets.

Another suspicious death is that of Philip Haney, a founding member of the Department of Homeland Security and whistleblower who exposed the Obama administration for purging records related to the Muslim Brotherhood. He wrote the book, *See Something, Say Nothing: A Homeland Security Officer Exposes the Government's Submission to Jihad*. He was found dead with a gunshot wound to his chest on February 21, 2020 and his death was ruled a suicide two years later. (The FBI "assisted" in the analysis of his death and took possession of various "contraband" documents found in his possession.)

Even if "suicide" were the cause of death, pressure from the FBI and other federal agencies can produce this result, as we will see in the anthrax letters case discussed later in this report.

Both the FBI and CIA were commandeered in the cover-up of the shutdown of TWA 800. In that disaster, which occurred under President Clinton and resulted in the deaths of 230 passengers and crew on July 17, 1996, federal "investigators" and the FBI and CIA blamed a fuel tank explosion when eyewitnesses saw missiles hit the plane.

An FBI sniper killed Randy Weaver's wife in the 1992 Ruby Ridge operation. She was killed as she held her baby daughter in her arms. Weaver's 14-year-old son was shot to death by federal Marshalls carrying machine guns. Ruby Ridge is the scandal involving the FBI and ATF assaulting a so-called "white supremacist" living in Idaho who had been set up on a charge of selling an illegal weapon, a sawed-off shotgun.

This time, they tried to set up Trump, first with manipulation of the crowd on January 6, 2021, and then as Trump prepared to run for the presidency again.

Jack Cashill's [book](#), *ASHLI: The Untold Story of the Women of January 6*, examines the case of Ashli Babbitt, who was unarmed and murdered by the Capitol Police, a federal law enforcement agency, on January 6, 2021. A military vet and Trump supporter, she was surrounded and murdered in cold blood but the Capitol Police officer who killed her was not prosecuted or even reprimanded.

Ruby Ridge was followed by the federal siege of the Waco religious compound on April 19, 1993, when more than 80 men, women and children were shot or burned to death. Federal agencies attacked the compound of a religious cult, the Branch Davidians, on the pretext that children were being abused. They could have apprehended the leader

of the religious compound without killing all those people. It was another blatant demonstration of their power.

Now they are using their power against Trump. The FBI, however, is just one part of “The Militarization of Federal Bureaucracy,” as a [report](#) from Open Books documented. “There are now more federal agents with arrest and firearm authority (200,000) than U.S. Marines (186,000),” its report said. The group notes, “Since 2006, [the IRS] spent \$35.2 million on guns, ammunition, and military-style equipment (CPI adjusted).”

Former conservative Rep. George Hansen wrote the 1984 classic, *To Harass Our People: The IRS and Government Abuse of Power*, and was jailed for allegedly filing false financial disclosure forms.

By contrast, Hunter Biden “willfully failed to pay his 2016, 2017, 2018, and 2019 taxes on time, despite having access to funds to pay some or all of these taxes,” according to his tax evasion indictment in December 2023. The long overdue indictment happened because of the spring 2023 testimony by IRS whistleblowers Supervisory Special Agent Gary Shapley and Special Agent Joe Ziegler about federal stonewalling and interference in the case. The CIA even [intervened](#) to stop the IRS from interviewing Patrick Kevin Morris, an associate of Hunter Biden.

Under President Barack Hussein Obama, the IRS harassed conservative and Tea Party groups. Anti-Trump Special Counsel Jack Smith, then an Obama Justice Department official, communicated with the IRS to target conservative groups for increasing auditing and criminal prosecutions.

An IRS contractor by the name of Charles Littlejohn stole and leaked the tax return information of many Americans, mostly on the right, including Trump, Senator Rick Scott, and Elon Musk, the billionaire owner of X (formerly Twitter) who has emerged as a major critic of the Biden Administration. Scott testified that, “The ugly truth is Mr. Littlejohn is getting this sweetheart deal [five years in prison] because his crimes advanced Joe Biden’s political agenda.”

More recently, the House Judiciary Committee and its Select Subcommittee on the Weaponization of the Federal Government released an interim [staff report](#) on “abusive unannounced field visits” by agency personnel, highlighting such cases as that of “Twitter Files” journalist Matt Taibbi.

Globally, another target, in addition to Trump, is Israeli Prime Minister Benjamin Netanyahu, already the subject of an arrest warrant from the United Nations’ International Criminal Court (ICC).

Before he was assigned to “get Trump,” Special Counsel Jack Smith conducted investigations and supervised “war crime prosecutions” at the ICC in The Hague, Netherlands. He was photographed in his global judicial garb, wearing black and purple robes, contemplating how to bring charges like genocide, war crimes, and crimes against humanity against certain world leaders. Since Trump became the first former

U.S. president to be formally charged with a federal crime, do not be surprised if Jack Smith's comrades engineer an indictment of Trump on the global level. The U.N. maintains [a prison cell](#) at The Hague.

In a threat personally directed against Trump, the head of Iran's Islamic Revolutionary Guards Corps promised retaliation for the U.S. assassination that Trump ordered of an Iranian terrorist, Qassem Soleimani. Suleimani headed the Islamic Revolutionary Guard Corps-Quds (IRGC) Force, responsible for producing many of our wounded warriors from Middle East conflicts.

Two Iranians were charged in 2011 for plotting the murder of the Saudi Ambassador to the United States on American soil. The plot involved [the bombing](#) of a restaurant that the Ambassador frequented and was visited by members of the U.S. Congress.

A Ricin-laced letter was sent to Trump by an anti-Trump activist from Canada by the name of Pascale Cecile Veronique Ferrier. The letter was intercepted and she was apprehended and [pleaded](#) guilty. Her letter called Trump "The Ugly Tyrant Clown" and said, "If it doesn't work, I'll find better recipe for another poison, or I might use my gun when I'll be able to come. Enjoy!" She had a loaded gun, 294 rounds of ammunition, a fake I.D., and a knife.

In yet another case, James Hodgkinson made online postings in which he referred to President Trump as a traitor, declaring "It's Time to Destroy Trump & Co." A follower of "Bolshevik Bernie" Sanders and avid TV watcher of Rachel Maddow's MSNBC show, he opened fire on Republican members of Congress, their staff, and members of their families in 2017. He fired at least 70 rounds from a 9mm pistol and an SKS 7.62mm rifle and critically injured House Majority Whip Steve Scalise.

Like many domestic radicals and even communists, however, he was never monitored by the FBI and was killed at the scene after opening fire.

A Secret Service after-action [report](#) noted that he wrote at least 27 letters to his local newspaper on such matters as "economic inequality" and "legalizing marijuana so that it could be a source of tax revenue for the government."

In response to one of my articles on the threat to Trump, one left-winger wrote to me, saying, "I doubt our government will try to assassinate him, but if they did, it would be a blessing. He MUST be stopped from being reelected this November."

JFK assassin Lee Harvey Oswald, a former Marine turned Marxist follower of Castro, is another example. Ex-communist and former Romanian intelligence officer Ion Mihai Pacepa wrote, *Programmed to Kill: Lee Harvey Oswald, the Soviet KGB, and the Kennedy Assassination*, a book that explains how he was recruited and programmed to kill by the KGB. A 20-page [version](#) on our web site examines how secret codes and messages were used to direct his mission to kill JFK.

Former FBI agent Herman Bly's book, *Communism, the Cold War, and the FBI Connection*, explains that the U.S. Intelligence Community, including the CIA and FBI, engaged in a cover-up regarding the facts about Oswald and his communist connections out of fear of another military confrontation with Soviet Russia.

Like Oswald, RFK assassin Sirhan Sirhan, a Palestinian Marxist, was programmed to kill by the communists. Sirhan hated RFK over his support of Israel.

As we saw in the plot to assassinate Supreme Court Justice Brett Kavanaugh, who was nominated by President Trump, there are many "activists" from the communist groups operating freely in American society without monitoring by the FBI who can be programmed to kill.

Nicholas John Roske was a pro-abortion activist upset about the draft of an anti-abortion decision leaked in advance from the Supreme Court. With the murder of Kavanaugh, he had declared on various Internet sites that he was going to stop the pro-abortion decision *Roe v. Wade* "from being overturned." Roske had also cited the school shooting in Uvalde, Texas, as a reason to kill Kavanaugh. In a bizarre twist, he wanted to kill Kavanaugh because he thought the justice would rule in favor of gun rights. However, he got cold feet and turned himself in to the local police.

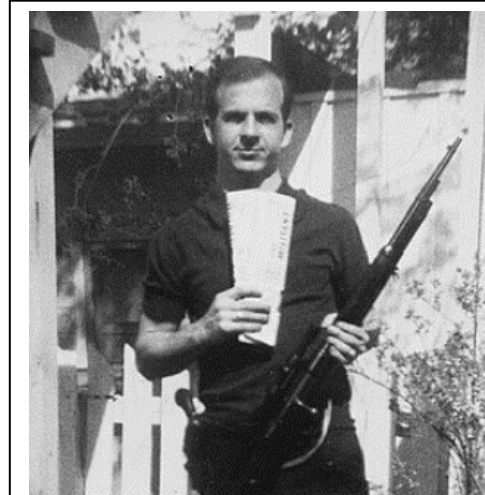
In the on-line conversations, Roske exhibited symptoms of gender dysphoria and called himself "Sophie," indicating he identified as female. Clearly, he was a product of Cultural Marxism.

In an official report, it was announced that after an eight month investigation the Marshal of the Supreme Court and her team could not "identify a person responsible [for the leak] by a preponderance of the evidence," although Justice Samuel Alito said he had a "pretty good idea" who did it. He added "this made us targets of assassination."

Whatever the extent of his mental problems, Roske was rational enough to arm himself with a Glock 17 pistol with two magazines and ammunition.

Roske's planned assassination was preceded by official threats from a prominent Democrat, Senate Democrat Leader Charles "Chuck" Schumer. As noted in a congressional resolution introduced by Rep. Andy Biggs, who wanted Schumer condemned, the New York Senator participated in a rally outside of the

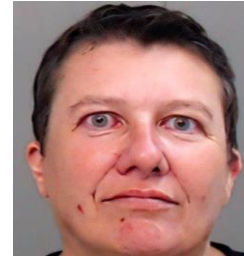
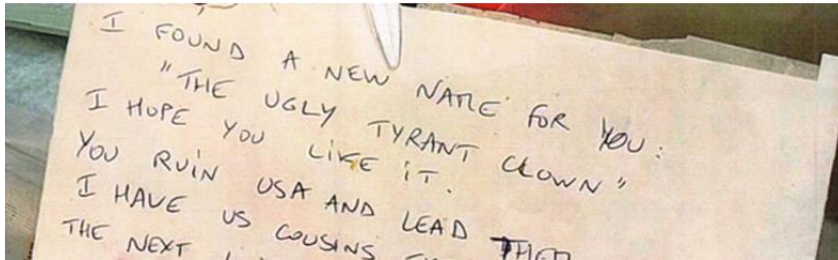
Supreme Court of the United States on March 4, 2020, at which he directed a threat at Justices Brett Kavanaugh and Neil Gorsuch. Schumer stated, "I want to tell you,

Gorsuch. I want to tell you, Kavanaugh. You have released the whirlwind, and you will pay the price. You won't know what hit you if you go forward with these awful decisions.”

“We don't monitor protests but we do share intelligence about specific threats of violence...” says FBI Director Christopher Wray. Such threats like of Schumer's are

ignored, even though they inspire and motivate violence-prone groups and individuals.

Equally significant, Congress once maintained committees on un-American activities and internal security, which examined such matters as “Castro's Network in the United States,” a 1963 Senate investigation into the “Fair Play for Cuba Committee” that included JFK assassin Lee Harvey Oswald. These committees are now defunct.

Filling the void, America's Survival, Inc. (ASI) [covered](#) and photographed the communist-organized “Free Palestine” rally in Washington, D.C. on November 4, 2023, organized by openly Marxist groups serving the interests of Russia, China, Iran, and North Korea. Out of these Marxist organizations, such as we saw in the case of Lee Harvey Oswald and the Fair Play for Cuba Committee, come violence-prone individuals and even presidential assassins.

Former State Department intelligence analyst Kenneth J. Dillon, who closely monitors communist intelligence operations, has [developed](#) “The KGB Theory of American Assassinations,” a controversial thesis about KGB operations on American soil that requires careful consideration as we contemplate what could happen to Trump.

Historically, Soviet involvement in the “wet business” of assassinations includes the notorious cases of expelled communist Leon Trotsky, murdered by KGB agent “Jacques Mornard” in Mexico in 1940, and the attempted assassination of Pope John Paul II in May 1981. President Reagan's CIA director Bill Casey confirmed the Soviet role in the murder attempt, in the face of official CIA resistance to the finding.

Foreign intelligence services have as much opportunity to kill Americans as the U.S. intelligence agencies, which have been infiltrated by the Russians and then engage in cover-ups after the fact for the benefit of their communist agents. Annie Jacobsen's book, *Surprise, Kill, Vanish: The Secret History Of CIA Paramilitary Armies, Operators, And Assassins*, purports to explain how the Intelligence Community eliminates enemies

of the United States but also has a short and incomplete section on how the KGB carries out assassinations. They clearly work together in some ways.

Our own domestic intelligence and law enforcement agencies sometimes kill openly, as we saw in the bloody sieges of Waco and Ruby Ridge. They literally murdered dozens of Americans in these armed assaults. Little accountability was forthcoming, leading to even more abuses under Obama and Biden, such as the armed raid on Trump's home, as well as armed raids on and the imprisonment of pro-life Christians. The FBI has a ["litmus test"](#) to weed out pro-Trump agents.

Historically, a big part of the problem is that FBI counterintelligence special agent Robert P. Hanssen was a Soviet/Russian mole inside the bureau and that his record of treason spanned 22 years, from 1979 to 2001. Robert S. Mueller, the Russia-gate special counsel, became FBI director after Hanssen was caught but then failed to reform the bureau to catch future spies.

Under Mueller, the investigation into the post-9/11 anthrax attacks that killed five Americans was officially "closed" after the agency conveniently blamed a dead man, scientist Bruce Ivins, who committed suicide under FBI pressure, for the anthrax murders. Another suspect in the case, Dr. Steven Hatfill, was hounded by federal agents but stood up to the pressure and eventually collected a financial settlement from the federal government for the damage to his career and reputation.

From the start of the FBI's inquiry, the bureau seemed determined to eliminate Al Qaeda as a source of the attacks, even though the terrorist group's biological weapons program was [run](#) by an identified Soviet KGB agent, Ayman al-Zawahiri.

In Russia-gate, the evidence produced by Special Counsel John H. Durham shows that the Russians originated the idea that Trump was a Russian agent and provided the "disinformation" in the so-called Steele dossier which drove the FBI investigation. Kevin Clinesmith, the FBI attorney who admitted falsifying evidence to fuel the bogus investigation, was never imprisoned.

FBI officials may have been so anti-Trump that they were willing to use Russian disinformation to paint Trump as a Russian agent. But it could also be the case that Russian agents or sympathizers in the FBI knew the information was false and therefore disinformation and used it anyway. It means that the "Crossfire Hurricane" investigation of Trump was a Russian "active measures" operation using communist disinformation and propaganda from the beginning.
